Regular City Council Meeting of Hebron Estates, Mayor Jerry Clark called the meeting to order at 7:00pm.

Commissioners present Robert Denner, Russell Forshee, Kathy Merrifield and James Tucker Also, in attendance: City Attorney, Mark Edison and Acting City Clerk, Dee Petzold

- → Acting City Clerk, Dee Petzold. read the regular meeting minutes from December 3, 2019. Commissioner Robert Denner made a motion to accept the regular meeting minutes as read. Commissioner Russell Forshee 2nd the motion. All were in favor. Motion carried.

OLD BUSINESS

- Lity Attorney Mark Edison sent a letter to Louisville Water Company concerning the dumpster. Their intent is to do away with the dumpster within the month.
- ♣ Attorney Edison advises according to Ordinance, Mr. Roederer on Scenic Trail must be cited daily until a total of \$5000 is reached then the City will file suit later. Attorney Edison advises Chief Reynolds to cite resident at 3807 Scenic Trail \$100 per day until all portable on demand containers are either moved out of sight from roadway or removed from property.
- → Attorney Edison also advised; Four Seasons HVAC should also be fined according to the Dumpster Ordinance passed November 1, 2019 for being able to see garbage from street.
- ♣ Robert Denner made a motion to modify existing Ordinance on dumpster enclosures to include all dumpsters required to have enclosures. Russell Forshee 2nd the motion. James Tucker and Kathy Merrifield both voted no. Mayor Clark voted aye. Motion carried.

NEW BUSINESS

- → Mayor Clark informed all in attendance of the sudden passing of the City Clerk, Jennifer Picheo in December 2019.
- → Mayor Clark appointed Micheale McCauley as City Clerk starting February 1, 2020. James Tucker made a motion to accept the appointment of Micheale McCauley as City Clerk starting February 1, 2020. Russell Forshee 2nd the motion. All were in favor. Motion Carried.
- → Mayor Clark introduced the new City Clerk, Micheale McCauley will be starting in February 2020. She currently is the full-time City Clerk for Pioneer Village and the part-time City Clerk for Hunters Hollow.

- → Mayor Clark showed all a picture of a for rent sign that has been up for over two weeks on residents' property. Attorney Edison advises to have sign removed if on an easement.
- → Mayor Clark asked Attorney Edison for a Resolution to add Micheale McCauley and all Commissioners to the bank financials for signatures on checks.
- - o Previous sent letter to 3910 Scenic Trail for having a brush pile and mattress on property. Property still not cleaned up.
 - o Robards to clean up property.
- → Mayor Clark announces the City Hall hours will change to 5:30 pm to 6:30 pm every Tuesday effective January 7, 2020.

 - 12/23 dispatched to Burkland Blvd for a welfare check. Female was transported to hospital for evaluation.
 - o Increased traffic enforcement on Burkland Blvd in the morning before school starts. Several warnings were issued.
- ♣ 2019 Santa's Helpers Program was a huge success, helping over 65 children to have a great Christmas.
- → Chief Reynolds will start teaching DARE at Freedom Elementary and Maryville Elementary on January 15, 2020.
