- ♣ Run Report for Pioneer Village Police Department totals 193 total responses, 72 of which were calls to Hebron Estates. This number includes 36 traffic control and school walk-throughs. The remaining 36 responses were police runs.
- ♣ Chief DJ Reynolds reported the following events:
  - o Four Season HVAC has enclosed their dumpster on Burkland Blvd.

- o Portable on demand storage containers on Scenic Trail are not moved due to owner being at a rehab facility for knee surgery for up to 6 weeks. We will revisit and report in March. The first letter was sent in December 2018.
- o 1/14 non injury at Preston Hwy & Old Preston Hwy.
- o 1/16 two people attempting to steal fuel form CK Market but could not get pumps to work. They climbed on roof to seal copper wiring. They cut alarm wires. Both were charged with criminal trespassing, mischief and attempting to steal fuel.
- o 1/17 report of identity theft on Burkland Blvd.
- o 1/18 non injury at Preston Hwy and Hebron Lane.
