Minutes: Motion to approve February 5, 2018 minutes was made by Comm. Denner and seconded by Comm. Forshee; Passed 4/0.

Budget: A copy of the monthly budget statement for January and February was handed out. Motion was made to pay March budgeted bills by Comm. Denner and seconded by Comm. Forshee; Passed 4/0.

Chief Reynolds: The Chief reported that on, February 10, a semi- truck ran off the road (Burkland Blvd) while trying to turn around and was cited and fined \$500, plus the cost of damages. Also a driver of a blue mustang was pulled over for not obeying traffic laws and driving behavior and told the officer that he did not want to get into any trouble. The officer felt the driver definitely understood. The Chief also reported on dog complaints that were dealt with and his officers were still watching for students who were speeding in the mornings and afternoons.

New Business: Atty. Edison read Resolution 2019-01; no response was given by council. Atty. Edison explained that KIPDA was pushing the resolution.


