Minutes: Motion to approve March 5, 2019 minutes with 2 corrections was made by Comm. Tucker and seconded by Comm. Denner; Passed 4/0. Motion to approve April 9, 2019 special meeting minutes was made by Comm. Tucker and seconded by Comm. Forshee; Passed 4/0.

**Budget:** A copy of the monthly budget statement for April. Motion was made to pay May budgeted bills by Comm. Forshee and seconded by Comm. Denner; Passed 4/0.

Chief Reynolds: The Chief reported that the City of Hebron Estates had experienced 8 car break-ins over the past month at the following addresses: 3979 Scenic Trail, 3910 Scenic Trail, 3927 Scenic Trail, 3501 Horse Run Ct, 3402 Tony Ln., 3591 Willow Way, 3505 Burkland Blvd, and 5122 N. Preston Hwy. Also a driver of a blue mustang was pulled over for not obeying traffic laws and driving behavior and told the officer that he did not want to get into any trouble. The officer felt the driver definitely understood. The Chief also reported on dog complaints that were dealt with and his officers were still watching for students who were speeding in the mornings and afternoons.

Old Business: Mayor Clark explained to the council that he was in contact with the trucking company regarding the damaged done due to semi-truck that turned around illegally on Burkland Blvd and that the city would be receiving a check soon.
