MINUTES REGULAR CITY COUNCIL MEETING 7PM, JULY 7, 2020

Regular City Council Meeting of Hebron Estates, Mayor Jerry Clark called the meeting to order at 7:00pm on July 7, 2020.

Commissioners present Robert Denner, Russell Forshee, James Tucker and Kathy Merrifield. Also, in attendance: City Attorney, Mark Edison and City Clerk, Micheale McCauley

Invocation: James Tucker All recited the Pledge of Allegiance

- ⚡ City Clerk McCauley read the regular meeting minutes from June 2, 2020. James Tucker made a motion to accept the regular meeting minutes as read. Robert Denner 2nd the motion. All were in favor. Motion carried.
- ⚡ James Tucker made a motion to accept the financial report for June 30, 2020. Robert Denner 2nd the motion. All were in favor. Motion carried

OLD BUSINESS

- ⚡ Attorney Edison read the 2nd reading of Ordinance 2020-03 Business License. Robert Denner made a motion to accept Ordinance 2020-03 Business License. James Tucker 2nd the motion. The vote was 3 in favor with Russell Forshee voting against. Motion carried.

NEW BUSINESS

- ⚡ Attorney Edison read the 1st reading of Ordinance 2020-04 Insurance Tax.
- ⚡ Attorney Edison read the 1st reading of Ordinance 2020-05 Real Property Ad Valorem Tax.
- ⚡ Attorney Edison read the 1st reading of Ordinance 2020-06 Public Service Company Ad Valorem Tax.

COUNCIL BUSINESS

- ⚡ Mayor Clark will get bids to restripe streets in Hebron Estates from Bid Rite, Mago and Hall Construction.
- ⚡ Robert Denner made a motion to restrict front yard parking. Kathy Merrifield 2nd the motion. The vote was 2 in favor (Merrifield and Denner) and two against (Tucker and Forshee) Mayor Clark voted in favor of motion. Motion carried.
- ⚡ Mr. Cody was sent a letter by Attorney Edison.
- ⚡ CK's property was mowed by the City, a lien was filed on property and paid.
- ⚡ Mayor Clark will give a warning to the City's lawn service, Lawns N More to do a better job mowing easements
- ⚡ Mr. Roederer is in compliance with the Commissioners requests for the PODS to be placed on concrete. Mayor Clark waived fines.

- ⚡ Hester's Lawn Service will maintain the ditch monthly behind the Community Center at 3047 Burkland Blvd.
- ⚡ CK's property was cleaned up by Hesters Lawn Service along with the garbage enclosure being cleaned up and removed. A clean up lien will be place on property.

POLICE BUSINESS

- ⚡ Pioneer Village Police Department made 27 runs in Hebron Estates to include the following:
- ⚡ 6/24 – Burkland Blvd Homeowner rented a vehicle and allowed a female friend to drive away. She has not been seen since. This is still under investigation.
- ⚡ The new radio system will be ready to go live on August 19, 2020. We had to attend a class on how to operate the radios.
- ⚡ Pioneer Village Police and many other Police Departments will have a Zoom meeting with Sarah Hardin from Bullitt County Schools on July 21st to discuss possible increased traffic issues and any other issues law enforcement will need to know.
- ⚡ Mayor Clark asked Attorney Edison to contact Mr. Ferris again at the Bullitt County School Board to see if the school can use a different traffic pattern for entering and exiting school.
- ⚡ Chief Reynolds ran radar on Burkland Blvd several different times with no one going over speed limit. Also observed the speed on Scenic Trail without running radar.
- ⚡ Chief Reynolds issued a warning to a resident on Scenic Trail with a vehicle in the front yard with a dead battery. He was given seven days to correct problem.

PUBLIC BUSINESS

- ⚡ Ms. Bohannon asked how to get a copy of the financial report. Mayor Clark furnished a copy to her.
- ⚡ Ms. Bohannon inquired on the City Finances and the Budget for FY2020-2021 that was posted in the Pioneer News. Mayor Clark stated the Budget is an estimate of revenue to be received and also an estimate of expenditures to be spent for the fiscal year.
- ⚡ Mayor Clark estimated that it would cost the city \$55,000 to provide garbage services to all the residents of Hebron Estates per year if the City decides to.
- ⚡ Mayor Clark stated he will not have off duty police. The City of Hebron Estates will continue to use Pioneer Village Police Department.
- ⚡ A resident asked about a tree falling and who is responsible. Attorney Edison states if a tree falls on your property, you are responsible unless there was written notice sent to the homeowner prior to the tree falling.

- ⚡ Robert Denner made a motion to adjourn the meeting. Kathy Merrifield 2nd the motion. All were in favor. Motion Carried.
