Present: Mayor Clark, Commissioners Forshee, Tucker, Merrifield, Forshee, Clerk Picheo, Representative from the Pioneer News, and 9 guests.

Minutes: Motion to approve August 7, 2012 minutes, was made by Comm. Forshee and seconded by Comm. Tucker; Passed 3/0.

Budget: A copy of the monthly budget statement was handed out. Motion was made to pay August budgeted bills by Comm. Forshee and seconded by Comm. Tucker; Passed 3/0.

Old Business: Mayor Clark led a discussion on the City Community Center replacement sign. He reviewed bids for masonry to rebuild the sign. Motion was made to accept the bid by Riley Construction by Comm. Forshee and seconded by Comm. Tucker; passed 3/0.

Mayor Clark led a discussion on the insurance claim with Geigo for the sign repair. The Mayor explained that Geigo has not responded to his request and is working with the city's insurance agent for help.

Mayor Clark verified with Atty. Edison regarding the easement and the ditch concern on Paula Lane. According to Atty. Edison the ditch is not on the city's easement and is on private property.

Mayor Clark asked Atty. Edison for updates regarding the land survey. Atty. Edison said that the surveyor is in the process of drawing up the plans.

Atty. Edison read the seconded reading for ordinance 2012-04 Compensation for Mayor. Motion was made by Comm. Forshee and seconded by Comm. Tucker; Passed 3/0.

Mayor Clark led a discussion on the 2013 tax rate for Real Estate. Motion was made to make the rate .092 per \$100 of assed value was made by Comm. Tucker and seconded by Comm. Forshee; Passed 3/0.

Atty. Edison read the seconded reading of ordinance 2012-05 Real Property Ad Valerm Taxes. Motion was made to accept the ordained was made by Comm. Forshee and seconded by Comm. Tucker; Passed 3/0.
