

ORDINANCE NO. 2012-03

AN ORDINANCE LIMITING THE TIME THAT TRASH RECEPTACLES (CANS) CAN BE LEFT IN THE STREET RIGHT OF WAY OF THE CITY OF HEBRON ESTATES.

WHEREAS, the City Council of the City of Hebron Estates determined in 2002 that the mandatory collection of residential and/or commercial garbage and trash was in the best interest of all residents and visitors of the City of Hebron Estates, and

WHEREAS, by the terms of Ordinance No. 2002-04, the City Council created an exclusive franchise for the collection of all residential and commercial garbage and trash within the municipal boundaries of the City of Hebron Estates, and

WHEREAS, by the terms of Ordinance No. 2002-05, the obligations of the individual property owners/occupants were established, and

WHEREAS, the terms of Ordinance No. 2002-05 did not establish a time limitation for trash and/or waste or the receptacles for trash and/or waste to remain upon the right of way of any street within the municipal boundaries of the City of Hebron Estates, and

WHEREAS, some property owners and/or occupants of real estate have chosen to leave the trash and/or waste receptacles on the right of way of streets within the City creating traffic hazards, unsightly conditions, and the spreading of trash and/or garbage from these trash and/or garbage receptacles, now, therefore;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HEBRON ESTATES as follows:

SECTION ONE: COLLECTION POINTS

Points of collection of solid waste shall be from the roadside or curbside within public rights of way or other locations near buildings, parking lots, etc., on private property. In general, solid waste generated by residential uses shall be placed along the roadside/curbside fronting the subject property not more than twenty four (24) hours before scheduled collection day. All reusable storage (trash cans) containers shall be removed from the roadside/curbside by the property owner/occupant within twenty four (24) hours after collection. Residential/commercial uses providing bulk storage containers shall be located on private property in areas accessible to collection vehicles.

SECTION TWO: PENALTIES

Any owner, occupant and/or person having control or management of any property violating any provisions of this Ordinance shall be deemed guilty of a violation and shall upon conviction be fined not less than \$10.00 but not more than \$250.00 for each offense. Each day of violation shall constitute a separate offense.

SECTION THREE: PUBLICATION

This Ordinance shall take effect upon publication.

SECTION FOUR: REPEAL All ordinances or parts of ordinances in conflict with this Ordinance or any part of this Ordinance are repealed.

SECTION FIVE: UNCONSTITUTIONALITY Should any section, clause, line, paragraph or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.

Given first reading at a regular meeting of the City Council of the City of Hebron Estates, Bullitt County, Kentucky, on the 1st of May, 2012. Given second reading, voted upon and passed at a regular meeting of the City Council of the City of Hebron Estates, Bullitt County, Kentucky, on the 5th of June, 2012.
