MINUTES REGULAR CITY COUNCIL MEETING 7PM, OCTOBER 6, 2020

Regular City Council Meeting of Hebron Estates, Mayor Jerry Clark called the meeting to order at 7:00pm on October 6, 2020.

- + City Clerk McCauley read the regular meeting minutes from September 1, 2020. James Tucker made a motion to accept the regular meeting minutes with correction. Robert Denner 2nd the motion. All were in favor. Motion carried.

PRESENT LIFE SAVING AWARD

- + Mayor Clark and Chief Reynolds presented Pioneer Village Police Officer Nick Hibbs the Life Saving Award Certificate and Pin for his actions performed on July 7, 2020 to save a human life.

OLD BUSINESS

- + The City is waiting on Louisville Water Company to issue a temporary easement permit. The contractor will honor the bid priced in 2017 to fix drainage by Willow Way.
- + The 2nd Reading of Ordinance 2020-07 Establish Requirement for Off Street Parking in Residentially Zoned Areas of Hebron Estates. Attorney Edison read 2nd Reading of Ordinance 2020-07. Mayor Clark has received several complaints from current residents with gravel. Attorney Edison said no-one could be grandfathered from the Ordinance, but the Commissioners could change current proposed Ordinance in Section 4. Mayor Clark tabled the Ordinance until November's meeting.

NEW BUSINESS

- + Waste Management Representative, Andy Reynolds proposed a cost of \$44,943.96 for the collection of garbage for all in the City of Hebron Estates to be paid for monthly by the City of Hebron Estates. This price also includes a discount for businesses with one toter can. This does not include recycling which is \$3.61 per month. Robert Denner made a motion to accept Waste Management's proposed cost of \$44,943.96 for the City to pay for all residents and a discount rate for businesses within the City of Hebron Estates. Kathy Merrifield 2nd the motion. Vote was 3/1 with James Tucker voting against. Motion carried.

- + Russell Forshee made a motion for the City to donate \$350.00 to the Zoneton Fire District 2020 Halloween Event. Robert Denner 2nd the motion. All were in favor. Motion carried.
- + Mayor Clark proposes changes to the Taxes for 2021:
 - o discount period for Real Property Tax from current date of 11/30 to align with other Cities date of 10/31
 - o delinquent as of 1/1 with a 10% penalty and 1% interest per month
 - o face amount due date will remain the same at 12/31Attorney Edison said this would have to be done by Ordinance next year.

COUNCIL BUSINESS

- + Russell Forshee asking about drainage issue. Mayor Clark said the residents need to sign the easement release and be notarized by the City Clerk before it could be bid out.

POLICE BUSINESS

- + Police Run Report for September included 249 calls for service of the Pioneer Village Police Department which includes Hebron Estates' call for service as well.
- + Chief Reynold report includes:
 - o 9/17 at Hebron Ln & Preston Hwy – injury accident
 - o 9/19 at Scenic Trail – report of a disorderly person
 - o 9/23 at Burkland Blvd – report of a stolen gun
 - o 9/30 at Hebron Ln & Preston Hwy – injury accident
 - o All students are back in school as of 10/20, student drivers will be using the entrance at Freedom Elementary to get to North Bullitt parking lot.
- + Chief Reynolds introduced Police Officer / Detective JC Witherspoon. Officer Witherspoon updated all on the recent vehicle thefts and a few other issues in the City that have been resolved. The Pioneer Village Police Department encourages everyone to LOCK your vehicles, homes, garage, and sheds to potentially prevent a theft. Officer Witherspoon also stated the 2020 Chevrolet Tahoe is in the parking for all to view after the meeting.


PUBLIC BUSINESS

- + A Resident asked about the Prestige subdivision having a sign not to have rental property. Attorney Edison said the City does not have any documents.


ADJOURNMENT

- + James Tucker made a motion to adjourn the meeting. Kathy Merrifield 2nd the motion. All were in favor. Motion carried.


