

*Action to reject this Ordinance 9-2-86 Reverting*

HEBRON ESTATES ORDINANCE

AN ORDINANCE IMPOSING A LICENSE TAX OR FEE UPON CERTAIN BUSINESSES, OCCUPATIONS, TRADES, AND PROFESSION CARRIED ON, CONDUCTED, OR OPERATED WITHIN THE CORPORATE BOUNDARIES OF HEBRON ESTATES, REQUIRING ALL PERSONS, FIRMS, OR CORPORATIONS PURSUING SAME TO OBTAIN A LICENSE THEREFORE, AND PROVIDING PENALTIES FOR ENGAGING IN SAID CONDUCT WITHOUT OBTAINING SAID LICENSE.

The City Counsel of Hebron Estates, Kentucky, does ordain as follows:

SECTION I. Each person or business engaged for compensation in any trade, occupation, business, or profession within the corporate limits of Hebron Estates, shall procure from the City Clerk an annual license, and shall pay to the Clerk a fee for such license as is hereinafter provided for the privilege of engaging in such trade, operation, business, or profession.

SECTION II. As used in this ordinance, the word "person" shall include corporations, joint stock companies, partnerships, associations, and individuals.

SECTION III. The revenue derived from the license tax herein levied shall be paid into and become a part of the General Fund of the City of Hebron Estates, Section 4.

SECTION IV. The license tax herein levied shall be due on the first day of \_\_\_\_\_ in each year, unless otherwise stated, except that persons commencing or desiring to operate for only part of a license year, a business, occupation, or profession after the 1st day of \_\_\_\_\_ of the license year shall pay a pro-rated tax, except as otherwise specifically provided herein, equal to as many twelfths of the annual license tax as there are calendar months remaining in the license year, including the month in which the license is granted. The license tax herein levied shall be deemed delinquent if not paid thirty (30) days after same becomes due, and a penalty of 20% of the amount of the tax shall be added thereto.

SECTION V. The following fees or tax plus County Clerk's fee shall be paid by a person conducting or engaged in the following businesses, occupations, or professions:

- GROUP I. ALCOHOLIC BEVERAGES, SALE OF:
1. Liquor Dealers holding a state retail package liquor license \$200.00
  2. Alcoholic beverage dealer who holds a state distributor's or wholesaler's or brewer's license, making sales or deliveries in the City. 200.00
  3. Retail liquor license to sell by the drink 400.00
  4. Retail Beer License 200.00
  5. Renewal of Retail Beer License 200.00

GROUP II. AMUSEMENT:

- Billiard or pool rooms, bowling alleys, circus, carnivals, dance halls, skating rinks, theatres, and golf courses. 50.00

GROUP III. AUTOMOTIVE:

1. Automobile dealers in either new or second-hand automobiles or both, operating a place of business in the City. Not pro-rated. 50.00
2. Automobile filling station, dispensing gasoline, oils, and automobile accessories or parts, or engaged in repair work 50.00
3. Gasoline, lubricating oils, kerosene, or other oils sold at wholesale. 50.00
4. Auto repair shops either mechanical or bodywork 50.00

GROUP IV: BUSINESS SELLING HOME APPLIANCES, FURNITURE  
FOOD, FARM PRODUCTS, GROCERY, CLOTHING,  
VARIETY STORE ITEMS, AND DRUGS.

1. All retail businesses operated in Hebron Estates, shall be required to pay a \$50.00 license fee per year for such operation unless a higher license fee is set forth from a particular retail business herein.
2. Grocery concerns selling at wholesale and delivering their products within the City, either from business houses within the City, or from trucks. \$50.00
3. Interior decorators, soliciting, selling and installing draperies, rugs, linoleum, wallpaper, and other interior household decoration. 50.00
4. Lumber and building material dealers who either sell or deliver lumber or building materials. 50.00
5. Restaurants, or cafeterias, motels, florist, sawmills, landscaping, nursery, horticulture, livestock market, bakeries, and auctioneers. 50.00
6. Slaughterhouses, stone quarries, concrete plants, and asphalt plants. 200.00

GROUP V. PEDDLERS AND DOOR TO DOOR SOLICITORS

1. Agents, representatives, solicitors, or dealers not otherwise specifically provided for herein taking orders, soliciting business or making sales, at retail. Per Day.

2. Coffee or peanut roasters, ice cream wagons or trucks, or popcorn machines. 25.00
3. Trucks operating within the City from which sales or deliveries are made at wholesale or retail, and for which no other license is provided herein, per truck. 50.00

GROUP VI. PROFESSIONS AND OCCUPATIONS

1. Insurance agencies, real estate agencies, junk dealers, automotive or otherwise, businesses furnishing professional services not enumerated shall pay a fee for such business of \$50.00 per year. The following professional services are enumerated: legal services, medical services, optical services, dental services, accounting services, chiropractic services, veterinarian services, and engineering services. 50.00
2. Building contractors and building subcontractors and construction contractors. 50.00

GROUP VII. OTHER SERVICES:

1. Barber shops, beauty parlors, jewelry stores, laundries and dry cleaners, financial institutions such as small loan companies, mortgage companies, banks, and savings and loan institutions.

GROUP VIII. ALL BUSINESSES NOT OTHERWISE SCHEDULED 50.00

SECTION VI. L. Any person required by this Ordinance to obtain more than one (1) license for any one business location or building, when the fee for no one of such individual license exceeds \$50.00, but the total of such license fees exceed \$50.00, shall be permitted to obtain all of said licenses for a fee of \$50.00, provided, however, that malt beverages, beer, or alcoholic beverage licenses shall not be included within the meaning of this Section, but shall in all instances be required in addition to any other licenses and fees provided for same shall be paid.

2. No license shall be required for any farmer for the privilege of selling meat, poultry, vegetables, or other produce from his own farm as an incident to this farming business owned within the city limits.

3. Any person licensed to sell merchandise of any character or nature shall have the privilege of installing, repairing, and servicing same without an additional license.

SECTION VII. Each person required by this Ordinance to obtain a license or licenses shall obtain same on or before the license tax provided for herein becomes due from the City Clerk and shall disclose at the time of application for such license or licenses all occupations or businesses in which he is or will be engaged during the license year.

The City Clerk shall not issue any malt beverage, beer, or liquor licenses under this Ordinance until the applicant presents to him proof of the issuance to the applicant of a similar license by the State for the same period.

SECTION VIII. Any person violating any of the provisions of this Ordinance shall be fined not less than \$5.00 nor more than \$25.00 for each offense, each day during which a violation occurs or exists constituting a separate offense. Any person violating any of the provisions of this Ordinance as an agent or employee of another shall be subject to this penalty.

SECTION X. All Orders or parts of Orders in conflict with this Ordinance or any part of this Ordinance are repealed.

SECTION XI. Should any section, clause, line, paragraph or part of this Ordinance be held unconstitutional or invalid for any reason, the same shall not affect the remainder of this Ordinance.
