CITY OF HEBRON ESTATES REGULAR MEETING JANUARY 25, 2000



PRESENT: COMM. FRALEY, HANSEN, RUSSELL, MAYOR RICKETTS, CLERK FERGUSON, ATTORNEY EDISON, TOM BARR PIONEER NEWS, ETHIC COMMISSIONER PULLIAM, AND TWO GUESTS. ABSENT WAS COMM. MURPHY AND PLANNING AND ZONING REP. JERRY BURKE.

MINUTES: COMM. FRALEY MOVED TO ACCEPT THE MINUTES AS PRESENTED.

BUDGET: COMM. HANSEN MOVED TO PAY THE ROUTINE BILLS, LIABILITY AND BONDING INSURANCE'S; COMM. FRALEY SECONDED THE MOTION WHICH PASSED 3/0.

OLD BUSINESS:ATTORNEY EDISON CONDUCTED THE SECOND READING OF ORDINANCE 99-04 REGARDING REPAIR OF STREETS MAINTAINED BY CITY OF HEBRON ESTATES. COMM. HANSEN MOVED TO ADOPT ORDINANCE 99-04; SECONDED BY COMM. RUSSELL; PASSED 3/0.

COMM. FRALEY MOVED TO EXTEND THE DATE OF CONSENT OF THE INTER LOCAL AGREEMENT BETWEEN BULLITT CO. FISCAL COURT AND CITY OF HEBRON ESTATES REGARDING A TURNING LANE AT E. HEBRON AND PRESTON ST. COMM. HANSEN SECONDED THE MOTION WHICH CARRIED 3/0.

COMM. RUSSELL MOVED TO ADOPT THE RESOLUTION 2000-1 FOR THE CITY OF HEBRON ESTATES TO BE RECLASSIFIED FROM A SIXTH CLASS CITY TO A FIFTH CLASS CITY. MOTION SECONDED BY COMM. FRALEY; MOTION CARRIED.

ATTORNEY REPORTED ON THE COLLECTION OF PAST TAXES PRIOR TO 1993.

CLERK FERGUSON PRAISED JUDGE WARD AND ATTORNEY EDISON FOR JOB WELL DONE IN COLLECTING FOUR OR FIVE DELINQUENCIES. CLERK FERGUSON IS PLEASED WITH JUDGE WARD NOT LETTING PEOPLE BY WITHOUT PAYING THEIR TAXES. MORE GO TO COURT IN MAR.

NEW BUSINESS: ETHIC COMMISSIONER PULLIAM HAD COMMISSIONERS AND MAYOR COMPLETE FINANCIAL ISCLOSURE STATEMENTS FOR 2000.

MAYOR NOMINATED RODNEY BURNER FOR THREE YEARS ON THE ETHICS COMMISSION. COMM FRALEY MOVED TO APPROVE THE APPOINTMENT SECONDED BY COMM. HANSEN: MOTION CARRIED 3/0.

COMM. RUSSELL MOVED TO ACCEPT THE AUDIT REPORT COMPLETED BY HENSON AND SMITH ASSOCIATES; MOTION SECONDED BY COMM. HANSEN; PASSED 3/0. CLERK FERGUSON WILL MAIL THREE COPIES TO LOCAL GOVERNMENT.

FOLLOWING A DISCUSSION ON THE BLACKTOPING OF BURKLAND BLVD, SCENIC TRAIL (RIGHT OF BURKLAND) AND SCENIC DR. IT WAS GENERAL CONSENSUS OF COMMISSIONER'S THAT ATTORNEY EDISON WILL TAKE CARE OF GETTING THE ROADS BID FOR BLACK TOPPING. ATTORNEY EDISON WILL HAVE PIONEER NEWS PUBLISH THE REQUEST FOR BIDS.

COMM. HANSEN ASK THAT EVERYONE START TRYING TO FIND SOME PROPERTY OWNERS TO RUN FOR COMMISSIONERS IN THE ELECTION.

JAMES TUCKER, RESIDENT IS REQUESTING ASSISTANCE WITH SPEEDERS ON BURKLAND. TWO STUDENTS FROM NBHS HAVE BEEN DRAGGING SIDE BY SIDE.

ATTORNEY EDISON REPORTED THAT HE DID SEND TO STATE REPRESENTATIVE BELCHER A COPY OF THE 1949 CASE WHERE FISCAL COURT MUST MAINTAIN ROADS WITH SCHOOL.

MAYOR RICKETTS WILL GET THE SCENIC DRIVE STREET SIGN REPAIRED AND INSTALLED. HE REQUESTED IN THE FUTURE THAT ANYONE WHO SEES SOMEONE DAMAGE A SIGN, REPORT THEIR NAME AND LICENSE NUMBER SO THEIR INSURANCE CAN PAY FOR THE SIGN REPAIR.

COMM. FRALEY MOVED TO ADJOURN; SECONDED BY COMM. HANSEN; MOTION CARRIED.
