CITY OF HEBRON ESTATES MEETING JANUARY 27, 1998

RESENT: COMMISSIONERS CLARK, FRALEY, HANSEN, RUSSELL, MAYOR RICKETTS, CLERK FERGUSON, ATTORNEY EDISON, TOM BARR PIONEER NEWS, AND SEVEN GUESTS.

MINUTES: COMM. CLARK MOVED TO ACCEPT NOV. MONTHLY MEETING MINUTES AS PRESENTED; SECONDED BY COMM. RUSSELL; PASSED 4/0. COMM. HANSEN MOVED TO ACCEPT DEC. MONTHLY MEETING MINUTES AS PRESENTED; SECONDED BY COMM. FRALEY; PASSED 4/0.

BUDGET: A MOTION WAS MADE BY COMM. FRALEY TO PAY THE REGULAR BILLS INCLUDING ALLTEL, LGE, SALARIES, SMITH AND HENSON \$2200.00. SECONDED BY COMM. HANSEN. PASSED 4/0.

OLD BUSINESS: THERE WAS A LONG DISCUSSION ABOUT THE DANGEROUS SITUATION CORNER OF EAST HEBRON LANE AND PRESTON HIGHWAY. EAST HEBRON LANE IS COUNTY ROAD AND IS NOT UP TO OUR CITY STANDARDS. ATT. EDISON STATED THAT IT WAS STEVE TAYLOR THAT SAID THAT MUNICIPAL ROAD FUNDS CANNOT BE USED BY THE FISCAL COURT TO MAINTAIN ROADS IN ANOTHER CITY. IT WAS GENERAL CONSENSUS THAT HEBRON ESTATES PAYS A LOT OF COUNTY TAXES NOT TO BE ABLE TO GET THE INTERSECTION WIDENED FOR THE SAFETY OUR COMMUNITY AND ESPECIALLY THE SCHOOL CHILDREN. THE MAYOR AND ATTORNEY ENCOURAGED EVERY RESIDENT TO TALK TO THE FISCAL COURT MEMBERS. THE MAYOR WILL CONTINUE TALK TO THE OFFICIALS ABOUT WANTING THE INTERSECTION WIDENED.

IT WAS ANNOUNCED THAT THE COURT PROCEEDINGS ON THE PROPERTY OWNED BY CAROLYN HIBBARD REDMON HAVE BEEN RESENDED BY WALT SHOLARS OFFICE BECAUSE NO ONE WAS PRESENT FROM THE CITY. THE MAYOR SAYS NO ONE NOTIFIED HIM. ATT. EDISON SAYS WE WILL HAVE TO START ALL OVER WITH THE PROCEEDINGS.

COMM. RUSSELL REPORTED THAT ROBARDS WILL HAVE THE BLACK CAR WITH THE FLAT TIRE MOVED BY THE WEEKEND. HE WILL CONTACT MR. JOHNSON ABOUT A TEMPO PARKED AT HIS APTS. MS. FERGUSON REPORTED HAT MR. BAILEY WILL GET THE OLD MATTRESS MOVED FROM SCENIC TRAIL THIS WEEK.

NEW BUSINESS: ART HENSON WAS PRESENT TO GIVE AN EXPLANATION OF THE BUDGET AUDIT. BUDGET AMENDMENT WAS NECESSARY. COMM. FRALEY MOVED TO ACCEPT THE AUDIT AS PRESENTED; SECONDED BY COMM. RUSSELL; PASSED 4/0.

MAYOR RICKETTS APPOINTED RON PULLIAM TO ANOTHER THREE YR. TERM ON THE ETHICS COMMISSION. COMM. HANSEN MOVED TO ACCEPT THIS APPOINTMENT AND COMM. RUSSELL SECONDED WITH MOTION PASSING 4/0.

THERE WAS CONCERN THAT CARS ARE PARKING ON THE STREET. THERE HAVE BEEN COMPLAINTS ABOUT FOUR CARS ON GARDEN CT. SOMETIMES BLOCKS THE CUL-DE-SAC. COMM. HANSEN WILL GET THE CARS OFF THE ROAD. HE WILL GET THE LICENSE NUMBER AND GIVE TO ATT. EDISON.

A QUESTION WAS ASK ABOUT THE LEGALITY OF THE HOPELITE INC. BEING LICENSED TO HAVE A WHOLESALE GUN AND AMMUNITION BUSINESS IN OUR CITY. ATTORNEY ADVISED THAT THE ATF NEEDS A LETTER FROM THE CITY.

A DISCUSSION ABOUT THE BLOCKWATCH PROGRAM WAS CONCLUDED WITH MS. MUIR DISTRIBUTING A FORM FOR EACH PROPERTY OWNER TO COMPLETE. IT WAS SUGGESTED THAT A MEETING BE SCHEDULED TO EXPLAIN TO THE RESIDENTS THE IMPORTANCE AND THE PROCEDURE TO COMBAT AND PREVENT CRIME IN OUR CITY.

ATTORNEY EDISON ANNOUNCED THE NEED TO ESTABLISH THE NEW CITY COUNCIL COMPENSATION PRIOR TO MAY. THE DEADLINE IS AUG. 14, 1998

THERE WAS A DISCUSSION ON A LETTER FROM THE TRANSPORTATION CABINET ON THE MUNICIPAL FUNDS BEING RECEIVED MONTHLY OR 80% THE FIRST OF THE FISCAL YEAR COMM. RUSSELL MOVED THAT THE CITY OF HEBRON STATES RECEIVE MONTHLY THE MUNICIPAL FUNDS FROM THE STATE AS WE HAVE BEEN DOING; SECONDED BY COMM. HANSEN; MOTION PASSED 4/0.

A MOTION TO ADJOURN WAS MADE BY COMM. HANSEN; SECONDED BY COMM. FRALEY; PASSED 4/0.
