OLD BUSINESS: COMM. CLARK LED A DISCUSSION ON THE SNOW REMOVAL. COMM. MUIR STATED THAT THE STREETS LOOKED GREAT. CLERK HURST STATED THAT SHE NEVER RECEIVED ANY COMPLAINTS.
