## THE CITY OF HEBRON ESTATES FEBRUARY 7, 1995

MINUTES OF THE COMMISSIONERS MEETING.

PRESENT: MAYOR RICKETTS, COMMISSIONERS CARDWELL, HANSEN, MARSHALL,
CITY CLERK FERGUSON, ATTORNEY WOOLDRIDGE AND FOUR GUESTS.

COMMISSIONER FRALEY WAS ABSENT, HER HUSBAND WAS IN THE HOSPITAL.

MINUTES: A MOTION WAS MADE BY COMMISSIONER CARDWELL AND SECONDED BY COMMISSIONER MARSHALL TO APPROVE THE MINUTES AS PRESENTED.

BUDGET: CITY CLERK ANNOUNCED THAT SHE HAS RECEIVED THE \$10,000 BACK PAY FROM THE ROAD AID MONIES THAT WERE BEING HELD FOR THE UFIR FORMS. A MOTION WAS MADE BY COMMISSIONER CARDWELL TO APPROVE THE BUDGET AS SUBMITTED; SECONDED BY COMMISSIONER HANSEN; MOTION PASSED.

OLD BUSINESS: THE CLERKS DUTIES AND SALARY WAS DISCUSSED.
COMMISSIONER HANSEN MOVED TO INCREASE THE CLERKS SALARY TO \$4200
ANNUALLY; SECONDED BY COMMISSIONER CARDWELL; MOTION CARRIED.

MR. ROLAND, PRINCIPAL OF HEBRON MIDDLE SCHOOL WAS PRESENT TO REQUEST A NEW SIGN BE INSTALLED ON THE CORNER OF PRESTON ST. AND HEBRON LANE. MAYOR RICKETTS HAD DISCUSSED THE SIGN ISSUE WITH MR. HOSKINS AT NORTH BULLITT HIGH SCHOOL.THE H.S. PLANS TO ERECT A NEW BRICK SIGN, THE MAYOR FAVORED THE CITY DONATING A CONCRETE SLAB TO SET IT ON. COMMISSIONER HANSEN AND PRINCIPAL ROLAND VOLUNTEERED TO EXPLORE THE PROPER PLACE TO INSTALL THE SIGN AND GATHER INFORMATION AND DO THE ORDERING. IT WAS GENERAL CONSENSUS THAT THE CITY OF HEBRON PURCHASE TWO SIGNS; ONE TO FACE SOUTH ON PRESTON AND ANOTHER TO FACE NORTH ON PRESTON. COMMISSIONER MARSHALL SUGGESTED THAT THE CITY INSTALL THEIR. OWN POST. THE MAYOR WANTED TO IN CHARGE OF THIS PROJECT AND AGREED TO HAVE THE SIGNS ORDERED BY THE NEXT MEETING.

THE SIGN AT TONY LANE HAS BEEN PULLED OUT OF THE GROUND. MAYOR HAS MOVED THE STOP SIGNS THAT WERE TOO CLOSE TO THE STREETS.

STREET LIGHTS HAVE BEEN ORDERED FOR GRIDER DRIVE, PAULA, AND TAMMY. THIS WILL INCREASE THE LG&E BILL APPROX. \$11.00 EACH PER MONTH.

THE MAYOR IS WORKING WITH LGE ON WILLOW WAY TO BEGIN LIGHTING. HOWEVER, IT WILL COST APPROX. \$75.00 TO UNDER THE DRIVEWAYS. THERE WAS A DISCUSSION ON THE NUMBER OF LIGHTS, AREA TO BE INSTALLED, AND THE COST TO THE CITY. MS. FERGUSON ANNOUNCED THAT THE EG&E BILL WILL NO LONGER BE TAKEN FROM THE ROAD AID MONIES. SHE HAS A LETTER FROM CPA HENSEN AND FRANKFORT. SHE WILL HAVE TO CHANGE THE LEDGERS TO MAKE THE CHANGES. ATTORNEY WOOLDRIDGE THINKS IT IS BECAUSE OF THE NEW SYSTEM.

PINK SURVEY SHEETS COMPLETED WITH THE TAX BILLS WERE PRESENTED. THE COMMISSIONERS EACH VIEWED THEM AND READ THE RESIDENTS COMMENTS. MANY CONCERNS OF SPEEDING, LOCATION OF SIDEWALKS, &ETC.WAS DISCUSSED.

NEW BUSINESS: A WRITTEN BUDGET REPORT WAS GIVEN TO THE COMMISSIONERS. THE CERTIFICATE OF DEPOSIT FOR THIS BUDGET YEAR HAS BEEN TRANSFERRED FROM THE CHECKING ACCOUNT.

ATTORNEY WOOLDRIDGE WAS WAITING TO SEE IF OUR ETHIC ORDINANCE WAS ACCEPTED BY FRANKFORT. MAYOR RICKETTS HAS THE LETTER OF ACCEPTANCE. THE ATTORNEY WILL GET THE FORMS TO ALL CONCERNED FOR COMPLETION.

MR. GRAU, VISITOR REQUESTED HELP WITH SPEED LIMITS AND THEIR ENFORCEMENT. STATED HE WAS ALMOST HIT THREE TIMES WHILE WALKING. MAYOR EXPLAINED 25MPH IN CITY STREETS, COUNTY POSTED THE SPEED LIMITS OF 35MPH ON BURKLAND BLVD. EAST HEBRON LANE AND ETC. FOLLOWING A DISCUSSION AND CONSENSUS THAT SPEEDING IS A PROBLEM TO BE ADDRESSED IT WAS DECIDED THAT CHANGING SPEED LIMITS WAS NOT THE ANSWER. THE MAYOR AND ATTORNEY WILL REQUEST THE SHERIFF TO GET A SPEED UNIT IN THE CITY OF HEBRON ESTATES AT VARIOUS TIMES.

THERE WAS CONCERN THAT A TRACTOR TRAILOR IS CUTTING SHORT CORNERS IN PRESTIGE ESTATES. VANDALISM REMAINS A PROBLEM ALSO.

ATTORNEY WOOLDRIDGE ANNOUNCED THAT THE 1993 DELINQUENT TAX LIST WILL BE PUBLISHED IN THE NEWSPAPER. LIENS WILL BE PLACED ON THE PROPERTY.

ATTORNEY WOOLDRIDGE WILL MEET WITH JERRY BURKE ON 2/8/95 AND WILL DISCUSS THE REMOVAL OF EQUIPMENT ON BURKLAND BLVD.

THERE WAS A DISCUSSION REGARDING THE COMMERCIAL PROPERTIES. IT WAS ANNOUNCED THAT THE NEW CONSTRUCTION ON BURKLAND BLVD WILL BE A TRUCKING COMPANY. THERE WAS A DISCUSSION ON THE TRAFFIC. WE DO HAVE AN ORDINANCE FOR CONTROL OF COMMERCIAL VEHICLES.
