MINUTES: COMM. HANSEN MOVED THAT THE MINUTES BE ACCEPTED AS PRESENTED; MOTION SECONDED BY COMM. RUSSELL; PASSED 3/0

BUDGET: COMM. FRALEY MOVED TO ACCEPT AS PRESENTED; SECONDED BY COMM. RUSSELL; PASSED 3/0.

OLD BUSINESS: FOLLOWING A LONG DISCUSSION, IT WAS DECIDED THAT THE BLOCK WATCH MEETING WOULD BE ON MARCH 10, 1998 AT 7:00 P.M. IF MAYOR RICKETTS COULD SCHEDULE SPACE AT NORTH BULLITT H.S. MS.MUIR WILL CONTACT MR. HOCKENBERRY TO GIVE ANOTHER PRESENTATION.

NEW BUSINESS: COMM. HANSEN ASK ABOUT HEBRON LANE PROJECT. MAYOR WILL TALK TO THE MAGISTRATES AND MANHOLLAN AGAIN AND GIVE REPORT AT NEXT MEETING. MAYOR REPORTED TWO OF OUR CITIZENS HAVE BEEN APPOINTED TO THE CITIZENS BANK BOARD; GEORGE ROEDERS & LAYMAN BYERS.

COMM. RUSSELL WAS ONCE AGAIN ASK TO RIDE THE CITY AND LOOK FOR VIOLATIONS. HE REPORTED THAT ROBARDS HAS A CAR PARKED AT THE APARTMENTS AND MR. JOHNSON HAS DNE ALSO, MS. FERGUSON SAID SHE HAS SPOKEN WITH MS. JOHNSON AND THAT CAR WOULD BE MOVED, THERE WAS A LONG DISCUSSION ABOUT PARKING ON THE STREETS. FOLKS WERE INSTRUCTED TO GET THE VEHICLES NUMBER AND TURN IN TO ATTORNEY EDISON FOR ACTION.

COMM. HANSEN MOVED TO SEND CERTIFIED LETTERS TO PROPERTY OWNERS FOR THE FISCAL YEAR 1997 DELINQUENT TAXES AND IF THEY ARE NOT PAID BY 3/20/98 TO INITIATE LIENS. SECONDED BY COMM. RUSSELL. PASSED UNANIMOUSLY.

MS. PEGGY LAY HAD WRITTEN A NOTE TO CLERK FERGUSON REQUESTING THAT THE PENALTY AMOUNT FOR 1996 BE DELETED. CERTIFIED LETTER WAS DELIVERED TO HER PREVIOUS ADDRESS WHICH IS PROPERTY HER SON BOUGHT. POST OFFICE TRIED TO DELIVER IT THREE TIMES. THE CERTIFIED LETTER WAS NOT PICKED UP. A LIEN IS ON THE PROPERTY AND DONALD LAY JR. IS AWARE. IT WAS GENERAL CONSENSUS THAT PROPERTY STANDS FOR TAXES AND PENALTIES; AND TO BE FAIR TO EVERYONE, THE PENALTY MUST BE PAID IN ORDER FOR THE LIEN TO BE REMOVED.

COMM, HANSEN LED A DISCUSSION ON SALARIES FOR CITY OFFICIALS. THERE WILL BE OPENINGS TO BE FILLED THIS FALL. COMM. HANSEN MOVED THAT THE MAYOR RECEIVE \$200.00 A MONTH AND COMMISSIONERS RECEIVE \$40.00 A MONTH. COMM. FRALEY SECONDED THE MOTION WHICH PASSED 3/0.

JOE WELLS, STATE REPRESENTATIVE CANDIDATE GAVE A TALK AND ASK EVERYONE'S SUPPORT.

COMM. HANSEN MOVED TO ADJOURN; SECONDED BY COMM. FRALEY; MEETING ADJOURNED.
