## FEBRUARY 25, 1997

PRESENT: COMMISSIONERS CLARK, FRALEY, HANSEN, RUSSELL, MAYOR RICKETTS, ATTORNEY EDISON, MR. BARR-PIONEER NEWS AND EIGHT VISITORS.MS. FERGUSON WAS ABSENT.

MINUTES: DISPENSED WITH MINUTES UNTIL NEXT MEETING.

BUDGET: MOTION WAS MADE BY COMM. HANSEN TO PAY REGULAR BILLS INCLUDING LGE, POSTMASTER \$72.14, BONDING INSURANCE \$87.50; SECONDED BY COMM. FRALEY; PASSED 4/0.

OLD BUSINESS: MAYOR WILL MEET WITH MAGO CONST. THIS WEEK ON DAMAGE TO BLACKTOPPED DRIVEWAYS.

COMM. HANSEN REPORTED THAT HE AND COMM. RUSSELL HAVE NOT HAD TIME TO FINALIZE A LIST OF ORDINANCES.HE DISCUSSED POSSIBLE TAXES ON UTILITIES. ATTORNEY SUGGESTED THE SAME TIME FRAME AS THE PROPERTY TAXES.HE EXPLAINED THE EVALUATION WOULD COME FROM DEPT. OF REVENUE TO NINA MOONEY, COUNTY CLERK AND FINALLY TO CITY CLERK WHO WOULD COMPLETE THE TAX BILLING.

COMM. RUSSELL WANTS TO SET THE HEIGHT OF GRASS AND INOPERABLE VEHICLES ORDINANCE. HE WANTS THE ORDINANCES FINISHED SOON. MAYOR RICKETTS AGAIN REQUESTED THE PROPOSED ORDINANCES BE GIVEN TO THE ATTORNEY FOR COMPLETION.

COMM. HANSEN WANTS TO GO WITH STREET SIGNS. HE IS AWAITING A TAX EXEMPT NUMBER. MAYOR RICKETTS REPORTS THAT THE CLERK NEEDS A COPY OF PAPERWORK OF THE CITY'S INCORPORATION. ATTORNEY EDISON WILL MAIL A CERTIFIED COPY TO CLERK FERGUSON.

COMM. CLARK QUESTIONED IF THE COUNCIL VOTED TO PURCHASE CITY OF HEBRON SIGNS ENTERING FROM PRESTON.COMM. CLARK MENTIONED CAR REMAINS WITH FLAT AT THE APARTMENTS.

COMM.HANSEN REQUESTED INFORMATION REGARDING CONDEMNATION OF PROPERTY. ATTORNEY REPORTED THE COURT DATE IS SET FOR SEPTEMBER.

COMM. HANSEN ASKED ABOUT THE DELINQUENT TAXES PRIOR TO 1992. MAYOR STATED THAT A CURRENT LIST WILL BE AVAILABLE AT THE NEXT MEETING.

NEW BUSINESS: COMM. RUSSELL REPORTED POT HOLES ON BURKLAND. A DISCUSSION OF BLACKTOPPING FOR OLD SCENIC TRAIL, BURKLAND, AND EAST HEBRON LANE FOLLOWED. COMM. WILL START CALLING BILLY COUCH, MAGISTRATE. THESE ARE COUNTY ROADS AND THE CITY HAS ALREADY BLACKTOPPED SCENIC TR. AND PAID FOR THE SNOW REMOVAL LAST YEAR.

MAYOR RICKETTS EXPLAINED THE PROCEDURE FOR GETTING STREET LIGHTS REPAIRED IS THAT ANYONE CAN CALL LGE; USUALLY HE HAS DONE THE REPORTING. COMM. HANSEN WAS CONCERNED THAT A LIGHT IS OUT ON RUBY.

COMM. HANSEN MOVED TO ADJOURN THE MEETING; SECONDED BY COMM. FRALEY; MOTION CARRIED.
