Minutes: Motion to approve the February 3, 2009 minutes with the following corrections to change Accurate Automotive sign permit to the the correct business "Trans Shop" and to change 20 tours to 12 tours for Officer Cook was made by Comm. Tucker and was seconded by Comm. Duddy. Passed 4/0.

Motion to approve the special meeting minutes for Feburary24 was made by Comm. Tucker and seconded by Comm. Allen. Passed 4/0.

Budget: A copy of the monthly statement was handed out and reviewed. Motion to pay monthly bills was made by Comm. Forshee and seconded by Comm. Duddy; Motion Passed 4/0.

Officer's Report: Officer Cook reported a total of 8 tours with 20 hours worked. He reported on a burglary at Four Seasons business, and a possible gang event that did not take place. He also followed up on a concern with people who were cutting through on Horse Run Court.

Office Lerding reported a total of 12 visits, 7 traffic stops (all were due to speeding) with 20 hours worked. The officer followed up on a concern regarding people that were seen bringing in brush into the city. The concern was raised that it could have been dumped at the Girl Scout camp however, nothing could be found.

Old Business: Clerk Picheo stated that the city has 11 tax bills that have not been paid.

Mayor Clark read a letter from Rumpke regarding the complaint from the last meeting. Mayor stated that Rumpke has made a personnel change which should elevate the problem.

Mayor Clark stated that everything had been signed off for the Storm Water Inter- Local agreement and sent to Frankfort, Ky.

Terk Picheo gave an update on the FEMA training she attended. She explained that all the City Clerks from the northern cities met after the ning and decided not to join in with the county's contract due to our relativity small case. Clerk Picheo stated that once the debris removal was complete she would meet with Les Bandy from Bullitt County Emergency Service to submit the forms to FEMA.

Mayor Clark asked the council if they wanted to wait on reading the sign ordinance until next meeting. All commissioners agreed.

Mayor Clark asked the council if they wanted to vote on the Text Amendment Comm. Tucker stated that he wanted to wait until we had all the information. It remained tabled until the city received more information regarding the amendment.

Mayor Clark reminded the residents that Bullitt County Stock Yards will be opened for tree removal from 9am -6pm during the week and 8am -4pm on the weekends.

Mags. Laswell announced that a meeting would be held on March 12th to discuss how the county handled the recent storm.
