Present: Mayor Clark, Commissioners Duddy, Forshee and Tucker, Atty. Edison, Clerk Picheo, Officer Wilson, Tom Barr of neer News and 12 guests.

**Minutes:** A correction was made to the February 7th minutes to add, Commissioner Duddy abstained from the vote on the motion for the Ordinance that included an increase for next elected officials compensation. Motion to approve February 7, 2006 minutes with one correction was made by Comm. Tucker and seconded by Comm. Forshee; Motion Passed 3/0.

Budget: Motion to pay the bills, was made by Comm. Forshee and seconded by Comm. Duddy; Motion Passed 3/0.

Officer Wilson Report: Officer Wilson reported 22 hours worked (after approval from the Mayor) with 58 contacts. Officer Wilson stated that he has seen a 20% increase in citations and had recently arrested 5 people for suspicion of drug trafficking. Mayor Clark thanked him for his hard work in catching the criminals.

Introductions: The following candidates introduced themselves and asked for the community's support with their campaign and vote. Joe Laswell (currently Mayor of Fox Chase) is running for 3<sup>rd</sup> District Magistrate on the republican ticket. Monica Robinson is running for County Attorney on the Republican ticket. Larry Hatfield (currently solid waste coordinator) is running for County Clerk has several ideas such as, opening up satellite offices in different areas of Bullitt County, have Saturday hours and offer more web based information.

Old Business: Clerk Picheo reminded the council that we still have 14 unpaid tax bills and that one last reminder letter would be sent to their homes this month.

Comm. Duddy stated that he has no updates with the automated external defibrillators that will be donated by Jewish Hospital.

Comm. Duddy along with Mayor Gary Hatcher gave an update on Homeland Security. Mayor Hatcher explained that the city needed to decide as soon as possible on purchasing the radios. Comm. Duddy explained that the city would have to pay for our radios first and then be reimbursed for half of the cost from the grant money. Mayor Hatcher backed Comm. Duddy by stating the radios will be the central line of communication for all emergency departments. Comm. Duddy made a motion to purchase 3 satellite radios and was seconded by Comm. Forshee; Passed 2/1.

Comm. Forshee gave an update on the sign and explained that it had been engraved and is waiting to be picked up.

comm. Duddy reminded the council that NIMS requires the city to furnish badges for the officials. Comm. Duddy explained that we will have to figure out if we are going to by a program for ids or work something out. Comm. Duddy stated that Mayor Hatcher has a laminating machine that we can possibly use.

Comm. Duddy reminded the citizens that we have a block watch next Tuesday night.

Atty. Edison read a 2<sup>nd</sup> reading on the summary of Ordinance 2005-06; Flood Damage prevention. Motion to approve the Flood Damage Prevention Ordinance was made by Comm. Duddy and seconded by Comm. Tucker; Passed 3/0.

Atty. Edison read a 2<sup>nd</sup> reading on Ordinance 2006-02; Compensation for newly elected officials. Motion was made to approve the Ordinance by Comm. Forshee and seconded by Comm. Tucker. Passed 2/0 with 1 abstain vote.

New Business: A guest asked if the city had a contact for the League of Cities. Mayor Clark asked if Clerk Picheo would provide the resident with a contact name.

Comm. Tucker led a discussion on getting Hebron Middle or High School to pick up trash with litter abatement monies.

Comm. Duddy raised a concern that a dump truck had been coming down Willow Way and is tearing up the city roads. Comm. Duddy stated that he did not have the name of the company yet but was working on it.

Mayor Clark stated that the meeting in April would be canceled due to Comm. Murphy, Tucker and himself were not going to be here. Motion was made to cancel the April meeting by Comm. Tucker and seconded by Comm. Forshee. Passed 3/0.

Mayor Clark announced that the city would hold a special meeting to discuss the next year's budget on April 17<sup>th</sup> at 7:00 p.m. otion to adjourn was made by Comm. Tucker and seconded by Comm. Forshee; Passed 3/0. Meeting adjourned 8:17 p.m.
