CITY OF HEBRON ESTATES MEETING MARCH 23, 1999

PRESENT: COMM. HANSEN AND MURPHY, MAYOR RICKETTS, CLERK FERGUSON, ATTORNEY EDISON, MR. BARR PIONEER NEWS AND FIVE GUESTS. ABSENT WERE COMM. FRALEY AND RUSSELL AND PLANNING ZONING REPRESENTATIVE BURKE.

MINUTES: COMM. HANSEN MOVED TO ACCEPT THE MINUTES AS PRESENTED. COMM. MURPHY SECONDED THE MOTION WHICH PASSED.

BUDGET: COMM. MURPHY MOVED TO PAY THE ROUTINE BILLS ACCORDING TO BUDGET; SECONDED BY COMM. HANSEN; MOTION PASSED.

OLD BUSINESS: COMM. HANSEN MOVED THAT THE CITY PURCHASE THE DELINQUENT TAX BILLS ON THE LIST PRESENTED BY THE CLERK. MOTION SECONDED BY COMM. MURPHY. MOTION PASSED.

COMM. HANSEN CONCERNED OVER THE BILL TO LOUISVILLE GAS AND ELECTRIC EACH MONTH. MS. FERGUSON WILL WRITE THE COMPANY AND ASK FOR AN EXPLANATION WHY THE BILL IS NOT THE SAME EACH MONTH AND FOR A WRITTEN LIST OF THE LOCATION OF EACH STREET LIGHT AND THE COST. RON PULLIAM WILL ASSIST IN THIS PROJECT.

MAYOR RICKETTS WANTS TO ADD STREET LIGHTS TO HORSE RUN HOWEVER, THE ATTORNEY EXPLAINED THAT STREET LIGHTS CANNOT BE ADDED UNTIL THE ROADS ARE TAKEN INTO THE CITY AND THEY ARE NOT UP TO SPECIFICATIONS. COMM ISSIONERS FEEL MORE OF THAT AREA NEEDS TO BE DEVELOPED BEFORE ANYTHING IS DONE. WILLOW WAY WAS ALSO MENTIONED BUT THE SAME SITUATION EXISTS WITH THE STREETS.

A LONG DISCUSSION WAS HELD ABOUT THE BLACK TOPPING OF BURKLAND, OLD SCENIC TR. AND EAST HEBRON LANE. ATTORNEY EDISON EXPLAINED THAT STATE STATUE WAS NOT FOLLOWED BY THE COUNTY; PUBLIC WAS NOT NOTIFIED THAT THESE STREETS WERE BEING TAKEN OUT OF THE COUNTY ROAD SYSTEM. THEREFORE, THEY ARE COUNTY ROADS AND EVERYONE NEEDS TO CALL THE MAGISTRATE ED BLEEMEL AT 538-7372 WITH THEIR CONCERNS. SANDY MURPHY WILL ORGANIZE ANYONE WHO WOULD LIKE TO ATTEND A FISCAL MEETING TO EXPRESS OUR CONCERNS ON THE ROADS. THE MAYOR WILL MEET WITH ED BLEEMEL. ATTORNEY EDISON HAS BEEN INSTRUCTED TO TAKE WHATEVER ACTION NECESSARY TO SOLVE THE ROAD ISSUE. RESIDENTS PRESENT ARE REQUESTING FOR A QUICK RESOLUTION. MR. PULLIAM WANTS THE CITY TO ORGANIZE AND GET THE ROADS FIXED. MR. FREY HAS EXPLORED THE PAST ISSUES OF THE PIONEER NEWS AND FINDS THAT IT TAKES FOREVER FOR THE MAYOR AND COMMISSIONERS TO GET ANYTHING DONE. CITY OFFICIALS EXPRESSED THEIR FRUSTRATION OVER BULLITT COUNTY TRYING TO SAY THE STREETS MENTIONED ARE NOT COUNTY ROADS ESPECIALLY EAST HEBRON LANE WHICH HAS TWO MAJOR COUNTY SCHOOLS AND A GIRL SCOUT CAMP AT THE END OF IT. THERE ARE COURT RULINGS WHERE THE STREETS ARE COUNTY AND NO ONE CAN FIND ANYTHING TO THE CONTRARY.

THERE WAS DISCUSSION ABOUT THE EXCESSIVE NOISE AND NUISANCE REMAINING ON SCENIC TRAIL. CLERK FERGUSON WAS INSTRUCTED TO SEND VIOLATION LETTERS WHEN NECESSARY.

NEW BUSINESS: A DISCUSSION WAS HELD ON THE MEETING DATES FOR APRIL AND MAY. IT WAS DECIDED TO CANCEL THE APRIL MEETING SINCE THE SCHOOL WILL BE HAVING A SCHOOL FUNCTION AND WE CANNOT MEET ON THAT NIGHT.

THE MAY MEETING WILL BE HELD ON MAY 25,1999 ALTHOUGH THE SCHOOL WILL BE USED FOR THE ELECTION.

SANDY MURPHY AND MILLIE FRALEY ARE WORKING ON A LIST OF ORDINANCES FOR DISTRIBUTION.

COMM. HANSEN MOVED THAT WE ADJOURN AND COMM. MURPHY SECONDED IT; MOTION CARRIED.
