MINUTES: MOTION WAS MADE BY COMM. HANSEN AND SECONDED BY COMM. FRALEY TO ACCEPT THE MINUTES AS PRESENTED. MOTION CARRIED 3/0.

BUDGET: MOTION WAS MADE BY COMM. FRALEY AND SECONDED BY COMM. RUSSELL TO PAY THE BILLS AS PRESENTED. MOTION CARRIED 3/0.

OLD BUSINESS: COMM. FRALEY MOVED TO PURCHASE THE DELINQUENT 1999 TAX BILLS SECONDED BY COMM. RUSSELL AND MOTION PASSED 3/0. CLERK WILL PLACE LEINS ON THE PROPERTY AT THE COUNTY CLERKS OFFICE.

MAYOR REPORTED THAT MAGO WILL PATCH THE HOLES ON BURKLAND AND OLD SCENIC TR. BY THE END OF THE WEEK BUT IT WILL BE A MONTH OR TWO BEFORE THOSE STREETS ARE COMPLETELY BLACK TOPPED.

COMM. HANSEN REPORTED THAT A DRAINAGE PROBLEM DOES EXIST AT 3510 HEBRON LANE. TILE IS PLUGGED UP. ATTORNEY WILL DRAW UP EASEMENT AGREEMENT IF CITY HAS TO GET IT COMPLETED. MS. FERGUSON REMINDED THE COMMISSIONERS OF THE ORDINANCE REGARDING DAMAGE TO STREETS AND WHO EVER IS RESPONSIBLE FOR THE BLOCKAGE SHOULD BE HELD RESPONSIBLE TO REPAIR IT.

COMM. HANSEN MOVED TO PAY NORTH BULLITT H.S. \$1000.00 FOR OUR MEETING FACILITY. COMM. RUSSELL SECONDED THE MOTION WHICH CARRIED 3/0.

THERE WAS DISCUSSION REGARDING A COMMISSIONER AND PLANNING AND ZONING REP WHO HAD NOT BEEN IN ATTENDANCE FOR A FEW MONTHS. MS. FERGUSON STATED THE PLANNING ZONING REP IS NOT PAID.

COMM. FRALEY REQUESTED THE CITY LOTS BE MOWED. IT WAS ANNOUNCED THAT APRIL 8 IS COUNTY WIDE CLEAN UP. DUMPSTERS WILL BE LOCATED AT NORTH BULLITT H.S. CLERK WILL CALL MR. LUSH AND GET THE LOTS MOWED. MAYOR AND COMM. FRALEY VOLUNTEERED TO HELP TO PICK UP TRASH ON THE LOTS.

COMM. RUSSELL ASK MAYOR TO LOOK AT SIGNS IN THE CITY AND SITE VIOLATIONS

COMM. HANSEN ASK EVERYONE PRESENT TO CONSIDER THE POSITION OF COMMISSIONER. HE IS MOVING OUT OF THE CITY AND POSSIBLY WILL RESIGN AT THE NEXT MEETING.
