

CITY OF HEBRON ESTATES MEETING
APRIL 28, 1998

PRESENT: COMMISSIONERS CLARK, FRALEY, HANSEN, RUSSELL, MAYOR RICKETTS, CLERK FERGUSON AND SIXTEEN GUESTS. ATTORNEY WAS ABSENT.

MINUTES: COMM. CLARK MOVED TO ACCEPT THE MINUTES AS CORRECTED WITH THE DATE, SECONDED BY COMM. FRALEY AND PASSED 4/0.

BUDGET: COMM. FRALEY MOVED TO PAY THE REGULAR BILLS;SECONDED BY COMM. RUSSELL; MOTION PASSED 4/0.

OLD BUSINESS: SECOND READING OF ORDINANCE 98-01 TO ESTABLISH COMPENSATION FOR THE MAYOR, CITY COUNCIL PERSONS OF THE CITY OF HEBRON ESTATES WAS READ BY MAYOR RICKETTS IN THE ABSENCE OF ATTORNEY EDISON.FOLLOWING A DISCUSSION A MOTION WAS MADE TO PASS THE ORDINANCE AS READ BY COMM. HANSEN AND SECONDED BY COMM. FRALEY; PASSED 4/0.

COMM. HANSEN INQUIRED ABOUT THE COURT DATE TO COLLECT TAXES PRIOR TO 1992.ATTORNEY WAS NOT AVAILABLE TO DISCUSS HIS PLANS. CLERK STATED THAT WE ARE IN THE PROCESS OF PLACING THE LEINS ON 1997 DELINQUENT TAXES.

CARS PARKING ON THE STREETS ARE BETTER.

MAYOR IS AWAITING ORDINANCE ADOPTION BEFORE SIGNS ON WEIGHT LIMITS ON BURKLAND AND EAST HEBRON ARE INSTALLED. CLERK STATED THAT NO TEAR SHEET COULD BE FOUND ON ORD. 88-02 AND ATTORNEY EDISON SAYS ORDINANCES ARE NOT OFFICIAL UNTIL PUBLISHED. IT WAS DECIDED TO STUDY THE PROPOSED ORDINANCES AND HOLD UP ON THE SIGNS ANOTHER MONTH.

NEW BUSINESS: MAYOR DISCUSSED A LETTER HE HAD RECEIVED FROM JUDGE HARPER REGARDING THE ROAD MAINTENANCE OF ROADS LOCATED IN THE CITY. JUDGE HARPER LISTED STREETS THAT THE CITY HAD NOT ACCEPTED SUCH AS FARO CT. AND EAST HEBRON LANE. IT WAS UNDERSTOOD THAT THE COUNTY CANNOT MAINTAIN ROADS OUT OF THE STATE MUNICIPAL ROAD MONEYS. THIS BROUGHT QUESTIONS AS TO WHY OUR CITY ROADS COULD NOT BE MAINTAINED OUT OF THE COUNTY GENERAL MONEYS. WE ALL PAY COUNTY TAXES AS WELL AS CITY TAXES. CLERK SUGGESTED THAT THE COUNTY SHOULD PLACE EXTRA MONEY IN THE BUDGET TO TAKE CARE OF OUR ROADS. SHE REQUESTED A COPY OF THE LAW PASSED IN FRANKFORT TO THIS EFFECT. THE LETTER MAYOR RICKETTS SHOWED US WAS FROM JUDGE HARPER. VARIOUS OPTIONS WERE DISCUSSED. THE MAYOR HAS TURNED THIS OVER TO ATTORNEY EDISON. HE STATED THAT WE CANNOT SPEND CITY ROAD AID ON COUNTY ROADS AND ESPECIALLY THOSE NOT TAKEN INTO OUR SYSTEM. THE CLERK SUGGESTED THAT A LETTER BE PUT IN THE PAPER AGAINST THE FISCAL COURT MEMBERS WHO VOTED AGAINST OUR TURNING LANE AT EAST HEBRON LANE. THE MAYOR DID NOT WANT THE CITY TO DO THIS BUT ENCOURAGED EACH INDIVIDUAL TO SEND A LETTER.

FOLLOWING THE REGULAR MEETING A BLOCKWATCH MEETING WAS TO BE HELD BY MS. MUIR,CHAIRPERSON. A MOTION TO ADJOURN THE MEETING WAS MADE BY COMM. FRALEY AND SECONDED BY COMM. HANSEN; PASSED 4/0.
