PRESENT: COMMISSIONERS FRALEY, MURPHY, HANSEN, RUSSELL, MAYOR RICKETTS, CLERK FERGUSON, ATTORNEY EDISON, ERIN WILKINS PIONEER NEWS, JERRY BURKE. PLANNING AND ZONING REP. AND APPROX. 6 GUESTS.

MINUTES: A MOTION WAS MADE BY COMM. HANSEN AND SECONDED BY COMM. RUSSELL TO ACCEPT THE MINUTES AS PRESENTED.MOTION PASSED. THERE WAS NO APR. MTG.

BUDGET: MOTION WAS MADE BY COMM. FRALEY AND SECONDED BY COMM. MURPHY TO PAY THE BILLS; MOTION PASSED 4/0.

OLD BUSINESS: FOLLOWING A DISCUSSION ABOUT THE OUTDOOR LIGHTS IT WAS GENERAL CONSENSUS THAT THE CLERK SHOULD DO WHATEVER IT TAKES TO GET AN ITEMIZED LIST BY LOCATION OF THE LIGHTS AND TOTAL COST. IT MAY BE POSSIBLE TO DISCONTINUE LIGHTING AND START ALL NEW CONTRACTS IF LGE WILL NOT PROVIDE THE INFORMATION. MS. FERGUSON HAS WRITTEN A LETTER REQUESTING INFO ON MAY 13 AND BEEN MAKING VERBAL REQUESTS SINCE JULY 98.

MR.&MS. ASBAUGH AND RHONDA MESSER WERE PRESENT TO REQUEST CITY HELP WITH THE WEEDMAN PROPERTY. PARKING ON STREET, 3 VEHICLES WITH NO PLATES, DRINKING, WEEDS, NO STORM DOOR, JUNK VEHICLES. CLERK INFORMED THEM THAT VIOLATION LETTERS HAVE BEEN SENT APPROX. YEARLY AND NO ONE WILL ACCEPT THE CERTIFIED LETTERS. MAYOR INSTRUCTED THE PROPERTY OWNERS TO CALL POLICE OR GO TO THE COUNTY ATTORNEY'S OFFICE AND TAKE OUT COMPLAINT. COMM. HANSEN REQUESTED J. BURKE TO ASSIST AND HAVE MR. MILLER WITH PLANNING AND ZONING TO ASSIST WITH GETTING THE CARS REMOVED. ANIMAL CONTROL WILL BE CALLED ABOUT THE DOGS. MR. ASBAUGH STATED THAT THE SHERIFF DID NOT PICK THEM UP WHEN INTOXICATED. MR. BURKE ADVISED THEM TO CALL THE 800 NUMBER FOR THE STATE POLICE IN E-TOWN.

MAYOR RICKETTS WAS PRESENTED WITH FOUR PICTURES FROM MS. RUSSELL OF JUNK AND WEEDS ON THE CAROLYN HIBBARD PROPERTY. MAYOR WILL CHECK THE PROPERTY AND A VIOLATION LETTER WILL BE SENT IF NECESSARY. OTHER PROPERTIES MENTIONED WERE THE HORSE RUN ESTATES NEEDS MOWING, BURKE PROPERTY, RUEDS, WEBB, GRIDER, ETHERTON AND OTHERS. MAYOR SAID THAT THE COMMITTEE WILL RIDE THE ENTIRE CITY AND VIOLATIONS WILL BE SENT AS SOON AS POSSIBLE. MS. FERGUSON HAS ALREADY SENT SOME AND IT WAS GENERAL CONSENSUS TO TAKE OUT COMPLAINTS WITH WALT SHOLAR, BULLITT CO. ATTORNEY IF EVERYONE DOES NOT ABIDE BY THE ORDINANCES. MR. MCGUFFIN WAS DISGRUNTLED ABOUT HIS VIOLATION LETTER TO MOW HIS COMMERCIAL LOT. MCGUFFIN COMPLAINED THAT ORDINANCES ARE NOT ENFORCED FAIRLY.

NEW BUSINESS:1ST READING OF THE BUDGET 1999-2000 COMPLETED BY ATTORNEY EDISON.

THERE WAS A LONG DISCUSSION ABOUT THE THREE ROADS THAT BULLITT CO. FISCAL COURT CONTEND ARE NOT COUNTY ROADS ANYMORE. ATTORNEY EDISON RECOMMENDS THAT ALL AVENUES BE USED BEFORE BRINGING SUIT. HE RECOMMENDED THAT THE MAYOR AND CITY OFFICIALS APPROACH FISCAL COURT IN PERSON TO PUT MONEYS IN GENERAL FUND TO REPAIR AND RE-SURFACE THE THREE ROADS ESPECIALLY EAST HEBRON LANE SINCE IT IS ONE OF THE COUNTY'S MOST TRAVELED ROAD WITH TWO SCHOOLS, GIRL SCOUT CAMP AND CHURCH. HE SAID IT WAS UP TO THE MAGISTRATES AND COUNTY JUDGE AS TO WHAT GETS PAVED. EVERYONE IS ASKED TO ATTEND THE FISCAL COURT MTG. ON JUNE 1 AT 9:30 A.M. AND BRING SOME PROPERTY OWNERS WITH YOU. MANY WERE AMAZED THAT TWO MAGISTRATES (BLEEMEL AND MCLEARN) HAVE ATTENDED OUR MONTHLY MEETINGS AND DID NOT UNDERSTAND THE MATERIAL THEY HAD RECEIVED AND APPARENTLY HAD NOT BOTHERED TO LEARN HOW TO GO ABOUT TAKING COUNTY ROADS OUT OF THE SYSTEM LEGALLY. A MOTION WAS MADE BY COMM. HANSEN THAT THE MAYOR GET AN AGENDA OF THE NEXT FISCAL COURT MTG. AND REQUEST COUNTY ROADS WITHIN THE CITY OF HEBRON ESTATES BE PUT IN THE BUDGET TO BE MAINTAINED BY THE COUNTY SYSTEM. MOTION WAS SECONDED BY COMM. RUSSELL. MOTION PASSED 4/0.

MR. FREY, PROPERTY OWNER ON BURKLAND IS VERY UPSET AT HOW THINGS IN THE CITY TAKE SO LONG TO GET DONE. HE WAS VERY VOCAL ABOUT THE NEEDED ROAD REPAIR IN THE CITY.
