Present: Mayor Clark, Commissioners Tucker, Allen, Forshee, Duddy, Atty. Edison, Clerk Picheo, Tom Barr from the Pioneer News, Officer Cook, Officer Leroy, Magistrate Joe Laswell and 6 guests.

Minutes: Motion to approve the May 5, 2009 minutes with the following corrections to remove "Officer Cook arresting the individual" and change the prescription program to include the "City of Hillview". Motion to approve the May 2 , 2009 minutes with the corrections was made by Comm. Duddy and seconded by Comm. Tucker ; Passed 4/0.

Budget: Motion was made by Comm. Forshee to set aside the budget review until next meeting and seconded by Comm. Tucker; Motion Passed 4/0.

Officer's Report: Officer Cook reported a total of 9 tours with 20 hours worked and 10 contacts with 2 citations. He also reported on serving a court summons. Officer Cook followed up on a complaint regarding Spike's apartments and possible inappropriate behavior and did not see anything.

Officer Leroy reported 20 hours worked with 19 visits and 15 traffic stops all were speeding with 2 citations. He also reported on a situation on the county's watch where he stopped a burglary in progress on Creekview court due a neighbor reporting seeing a person kicking in the back door.

Old Business: Atty. Edison read the seconded reading of Ordinance 2009-02 Budget for fiscal year July 1, 2009 – June 30, 2010. Motion to approve Ordinance 2009-02 Budget for fiscal year July 1, 2009 – June 30 2010 was made by Comm. Forshee and seconded by Comm. Allen; Passed 4/0.

Clerk Picheo stated that the city has 3 tax bills that have not been paid.

Mayor Clark led a discussion on the unpermitted signed for Notebook Learning. He asked Clerk Picheo to request information so it can be reviewed at the next meeting.

New Business:

y. Edison gave a review on the text amendment. Motion to not approve the text amendment was made by Comm. Forshee and seconded by Comm. Allen; Passed 4/0.

Mayor Clark led a discussion regarding a resident who wanted to donate a couple of basketball goals for the city's parking lot. Comm. Tucker did not think that it would be good due to possible vandalism and trash that could be left behind. Comm. Forshee stated that he was worried about the liability. The council agreed not to take the goals.

Comm. Duddy led a discussion on several complaints that he had received regarding how grass cuttings from the corner lot on Willow and Preston were being blown into the street and onto other properties. A resident spoke up and said that he talked to the gentleman who was cutting the grass and asked him to stop and he said he would.

A discussion was led by Mayor Clark regarding the drainage situation on Burkland Blvd (in front of White's Concrete). Comm. Tucker made a motion to repair the tile at White's Concrete on Burkland Blvd. and was seconded by Comm. Forshee; Passed 4/0.

Motion to adjourn the meeting at 8:05 pm was made by Comm. Tucker and seconded by Comm. Allen Passed 4/0.
