

CITY OF HEBRON ESTATES
SPECIAL MEETING
JUNE 13, 1995

A SPECIAL MEETING OF THE CITY OF HEBRON ESTATES WAS CALLED BY THE MAYOR TO DISCUSS THE PURCHASE OF PROPERTY FOR FUTURE PROJECTS OF THE CITY. IT WAS HELD AT 6:30P.M. IN THE KY TURNPIKE DISTRICT WATER BUILDING. PRESENT WERE: MAYOR RICKETTS, COMMISSIONERS CARDWELL, FRALEY, HANSEN AND MARSHALL. ATTORNEY WOOLDRIDGE, CITY CLERK FERGUSON AND APPROXIMATELY TWENTY VISITORS. THE MAYOR AND COMMISSIONERS THANKED ALL THE VISITORS FOR COMING AND ENCOURAGED THEM TO ATTEND REGULAR MEETINGS ALSO.

THE MEETING BEGAN AS THE COMMISSIONERS AGREED TO OPEN THE FLOOR FOR DISCUSSION. EACH PERSON WHO HAD SIGNED IN TOOK A TURN TO SPEAK IN OPPOSITION OF PURCHASING PROPERTY ON EAST HEBRON LANE FROM THE KLINGLESMTHS. THOSE SPEAKING IN OPPOSITION WERE: RANDY SMITH, ED COWAN, DAVID CARNEY, DANNY ALLEN, CAROLYN SMITH, LORENE BERNARD, BETTY GLASSER, RON MUDD, BOB DENNER, CONNIE LEWTER, RON WISE, JANE COWAN, URBAN BERNARD, TONY AVERY, AND WALTER ROBERTSON.

AFTER LISTENING TO THE PROPERTY OWNERS; AND FROM TIME TO TIME THE CITY OFFICIALS TRYING TO EXPLAIN THEIR REASONS FOR PURSUING THE PURCHASE OF PROPERTY; COMMISSIONER HANSEN MOVED THAT WE GO INTO EXECUTIVE SESSION TO DISCUSS THE PURCHASE OF PROPERTY. SECONDED BY COMMISSIONER MARSHALL. MOTION UNANIMOUSLY CARRIED.

FOLLOWING EXECUTIVE SESSION, COMMISSIONER FRALEY MOVED THAT WE GO BACK TO THE REGULAR SESSION; SECONDED BY COMMISSIONER MARSHALL. MOTION PASSED 4/0. THE MAYOR ANNOUNCED THAT NO DECISIONS WERE MADE IN THE EXECUTIVE SESSION.

COMMISSIONER MAR4SHALL MOVED TO TABLE ANY DISCUSSION OR VOTING ON THE PURCHASE OF PROPERTY UNTIL THE NEXT REGULAR MEETING. SECONDED BY COMMISSIONER CARDWELL; MOTION PASSED 4/0.

COMMISSIONER CARDWELL MOVED THAT WE ADJOURN; SECONDED BY COMMISSIONER MARSHALL. MOTION CARRIED. THE NEXT MEETING WILL BE A REGULAR SESSION ON JULY 5, 1995--SAME PLACE AND TIME.
