JUNE 22, 1999 CITY OF HEBRON ESTATES MONTHLY MEETING

PRESENT: COMMISSIONERS FRALEY, HANSEN, MURPHY, RUSSELL, MAYOR RICKETTS, ATTORNEY DISON, MS. WILKINS-PIONEER NEWS, STATE REPRESENTATIVE BELCHER, MAGISTRATE BLEEMEL AND AREE GUESTS

MINUTES: MOTION MADE BY COMM. HANSEN AND SECONDED BY COMM. FRALEY TO ACCEPT THE MINUTES AS PRESENTED. MOTION CARRIED.

BUDGET: MOTION WAS MADE BY COMM. FRALEY AND SECONDED BY COMM. MURPHY TO PAY THE BILLS AS PRESENTED. MOTION PASSED 4/0.

OLD BUSINESS: CLERK FERGUSON GAVE A REPORT ON THE LGE LIGHTS. THE PRICE OF EACH LIGHT VARIES ACCORDING TO THE COST OF COAL, CURRENT RATE, AND ETC. A PACKET OF INFO WAS PRESENTED TO THE COMMISSIONERS. COMM.HANSEN WILL CHECK ON THE INFO SINCE HE FEELS EACH LIGHT WAS CONTRACTED TO BE ONE PRICE. THE MAYOR AGREED AND HE WILL GIVE THE CLERK A COPY OF THE CONTRACTS HE HAS APPROVED SINCE 1993.

COMM. FRALEY PRESENTED A PICTURE OF TRAILERS ON PROPERTY OWNED BY GERALD BURKE LOCATED ON FARO CT. A PROPERTY OWNER HAD GIVEN HER THE PICTURE AS HE COMPLAINED THAT IF HE HAD TO COMPLY WITH THE GARBAGE DUMPSTER ORDINANCE OTHER ORDINANCES SHOULD BE ENFORCED.HE COMPLAINED THAT THE TRAILERS AND WEEDS WERE UNSIGHTLY FOR HIS PROPERTY. MS. FERGUSON SAID THAT EVERYONE IS TREATED THE SAME AND SHE HAS SENT VIOLATION LETTERS. CLERK FERGUSON AND MAYOR RICKETTS WILL BE SENDING MORE VIOLATION LETTERS AND WILL TRY TO TAKE OUT COMPLAINTS WITH WALT SHOLAR. THE COMMISSIONERS AGREED THAT 6MOS. FROM THE PUBLICAITON OF THE DUMPSTER ORDINANCE WILL BE SEPT. 9 AND AT THAT TIME ALL DUMPSTERS MUST BE INVISIBLE FROM THE ROAD.

...TORNEY EDISON REPORTED THAT THE PAST TAXES WILL BE TAKEN TO COURT AT DIFFERENT DATES.

TOPIC OF "ROADS" WAS A VERY LENGTHY DISCUSSION. ATTORNEY EDISON ADVISED THE CITY AGAINST JOINING PIONEER VILLAGE IN THE LAW SUIT AGAINST FISCAL COURT. HE STATED THAT IF THE JUDGE RULES ADVERSELY WE ARE NOT PART OF IT BUT IF THE JUDGE RULES COUNTY ROAD THEN THE BULLITT CO. FISCAL COURT WILL HAVE TO MAINTAIN ALL COUNTY ROADS. STATUE PROVIDES COUNTY HAS TO PROVIDE SUITABLE ACCESS TO SCHOOLS. PROPERTY OWNER FREY ASK WHO TO SUE IF A WRECK RESULTS BECAUSE OF THE POTHOLES. IT WAS GENERAL CONSENSUS OF THE OFFICIALS THAT NOTHING BE DONE TO REPAIR E. HEBRON LANE. COMM. RUSSELL AND COMM. HANSEN WILL EVALUATE THE STREETS AND THE MAYOR WILL OBTAIN SOME BLACKTOP TO FILL LARGE HOLES.

BLOCK WATCH--MAYOR RICKETTS PRESENTED THE RESIGNATION OF CHRIS MUIR OF 6/21/99. CHRIS WILLMAN APPOINTED TO BE THE BLOCK WATCH CHAIRMAN FOR THE CITY OF HEBRON ESTATES. HE WILL ORGANIZE IT, AND CALL MEETING JUST FOR THE BLOCK WATCH ORGANIZATION. COMM. FRALEY MADE A MOTION TO ACCEPT AND COMM. MURPHY SECONDED IT; PASSED 4/0.

MAYOR PRESENTED A THANK YOU LETTER FROM NORTH BULLITT H.S. FOR THE USAGE MONEY.

MAGISTRATE BLEEMEL SPOKE CONCERNING THE TURNING LANE AT EAST HEBRON LANE AND PRESTON.HWY. HE STATED THAT SENATOR CASEBIER AND STATE REP. BELCHER ARE WORKING ON THE PROJECT. HE PROJECTS AN ESTIMATE OF \$50,000-\$75,000. MAYOR RICKETTS AND CLERK FERGUSON SAID IT WOULD NOT COST THAT MUCH IF BULLITT CO. FISCAL COURT HAD NOT REFUSED TO PUT IT IN WHEN THE BANK WAS GIVEN AN EXIT ONTO E. HEBRON LANE.
