

PRESENT: COMM. HANSEN, RUSSELL, MAYOR RICKETTS, ATTORNEY EDISON,
CLERK FERGUSON, AND THIRTEEN VISITORS. COMM. FRALEY AND COMM. CLARK WERE ABSENT.

MINUTES: MOTION WAS MADE BY COMM. HANSEN AND SECONDED BY COMM RUSSELL TO ACCEPT THE
MINUTES AS PRESENTED. MOTION PASSED UNANIMOUSLY.

BUDGET: A MOTION WAS MADE BY COMM. *Hansen correction mf.* RUSSELL AND SECONDED BY COMM. RUSSELL TO PAY THE BILLS AS
PRESENTED INCLUDING THE CBDG WORKSHOP BILLS AND MR. LUSH FOR MOWING. MOTION CARRIED.

OLD BUSINESS: FOLLOWING A LONG DISCUSSION AND REVIEW OF THE BIDS PRESENTED FOR THE MOWING OF
THE GRASS ON THE CITY'S PROPERTY WHICH IS LOTS 79-83 ON BURKLAND. THERE WAS DISCUSSION ABOUT
THE WEEDS IN FRONT OF CK'S MARKET AND THE LOOKS OF THE ENTRANCE OF THE CITY. SEVERAL RESIDENTS
FELT THE DITCHES SHOULD ALSO BE TRIMMED, BUT IT WOULD BE AN ADDITIONAL CHARGE. MAYOR RICKETTS
SAYS THE SURVEY MARKERS ARE ON THE CITY'S SIDE OF THE DITCH. MS. FERGUSON STATED THAT WE PAID
PRIOR TO HAVE THE DITCH CLEANED AND SHOULD BE MAINTAINED. JERRY BURKE SAID THE DITCH IS ON THE
CITY PROPERTY. THE MAYOR INSISTED HE WILL LOOK AT THE DITCH AND TAKE CARE OF THE DITCH
TRIMMING. COMM. RUSSELL MOVED THAT MR. LUSH MOW THE FIVE LOTS EVERY TWO WEEKS EXCEPT IN HOT
WEATHER AS LONG AS IT DOES NOT EXCEED 12 INCHES IN LENGTH FOR \$50.00 EACH TIME AND THE FIRST
TIME \$60.00. HE WILL USE A TRACTOR AND COMMERCIAL MOWER. THE MAYOR IS IN CHARGE OF TRIMMING OF
THE DITCH AS LONG AS IT DOES NOT EXCEED 12 INCHES AND THE COST IS NOT MORE THAN \$20.00. COMM.
HANSEN SECONDED THE MOTION. MOTION CARRIED.

MAYOR RICKETTS EXPRESSED HIS APPRECIATION TO JERRY BURKE FOR BEING REPRESENTATIVE OF PLANNING
AND ZONING FOR CITY OF HEBRON ESTATES.

A SECOND READING OF ORDINANCE 98-02 1997-1998 BUDGET WAS CONDUCTED BY ATTORNEY EDISON.
FOLLOWING A DISCUSSION BY COMM. RUSSELL IT WAS DECIDED TO PLACE THE \$15,000 IN SAVINGS INSTEAD OF
BUILDING FUND. MOTION WAS MADE BY COMM. HANSEN TO ACCEPT THE BUDGET AS PRESENTED. MOTION
SECONDED BY COMM. RUSSELL AND MOTION CARRIED. MS. FERGUSON WILL HAVE IT PUBLISHED IN THE
PIONEER NEWS.

A SECOND READING OF ORDINANCE 98-03 REGARDING SIGNS IN HEBRON ESTATES WAS CONDUCTED BY
ATTORNEY EDISON. SIGNS WHICH ARE REMOVED WILL BE KEPT BY THE MAYOR FOR ONE WEEK. COMM.
HANSEN MADE THE MOTION TO ACCEPT AND COMM. RUSSELL SECONDED THE MOTION WHICH CARRIED.

A GROUP OF RESIDENTS WERE PRESENT TO REQUEST ASSISTANCE WITH TEENAGERS ON SCENIC TRAIL. ONE
RESIDENT SAID THERE ARE AS MANY AS 15 TO 16 TEENAGERS AT ONE TIME AT 3927 SCENIC TR UNSUPERVISED.
ONLY TWO KIDS LIVE THERE. THEY ARE LOUD, USE FOUL LANGUAGE, SMOKE. OFTEN A CHAMPAGNE COLORED
TRUCK TRANSPORTS SOME IN FROM OTHER PLACES. MAYOR INSTRUCTED MS. FERGUSON TO SEND A LETTER
TO R.C. BEDWAY AND COPY OF THE NUISANCE ORDINANCE. MAYOR RICKETTS AND CLERK FERGUSON HAVE
RODE THE CITY AND ARE SENDING CERTIFIED LETTERS TO THOSE IN VIOLATION OF ORDINANCES AND PLAN TO
TAKE A COMPLAINT OUT WITH COUNTY ATTORNEY'S OFFICE.

THERE WAS A DISCUSSION ON POLICE PROTECTION FOR OUR CITY. THE MAYOR PRESENTED THE
COMMISSIONERS WITH A PROPOSAL FROM PIONEER VILLAGE POLICE FOR PART TIME COVERAGE FOR \$18,000.
COMM RUSSELL AND HANSEN ARE TO RESEARCH THE NEED FOR POLICE AND OTHER OPTIONS. THE MAYOR
TOLD THE COMM. THEY WOULD HAVE TO COME UP WITH REVENUE TO PAY FOR POLICE PROTECTION.

COMM. HANSEN MOVED THAT WE ADJOURN AND COMM. RUSSELL SECONDED THE MOTION. MOTION CARRIED.
NEXT MEETING WILL BE ON JULY 28, 1998.
