

CITY OF HEBRON ESTATES MEETING
JUNE 24, 1997

PRESENT: COMMISSIONERS RUSSELL, FRALEY, MAYOR RICKETTS, SHIRAL RYAN FROM PIONEER NEWS, ATTORNEY EDISON AND THREE GUESTS. ABSENT WAS COMM. CLARK, HANSEN AND CITY CLERK FERGUSON.

A MOTION WAS MADE BY COMM. FRALEY TO ACCEPT THE MINUTES AS CORRECTED WITH ORDINANCE 97-03 ; SECONDED BY COMM. RUSSELL; MOTION PASSED.

BUDGET: A MOTION WAS MADE COMM. RUSSELL AND SECONDED BY COMM. FRALEY TO PAY THE ROUTINE BILLS CONSISTING OF LGE, PHONE, FERGUSON, EDISON, POSTMASTER, LANDMARK AND ETC. MOTION PASSED.

OLD BUSINESS: THE SECONDED READING OF THE ORDINANCE 97-03 1997-1998 BUDGET WAS HELD BY ATTORNEY EDISON. A MOTION WAS MADE BY COMM. FRALEY TO ACCEPT AND SECONDED BY COMM. RUSSELL AND PASSED.

ATTORNEY EDISON ANNOUNCED THAT THE SEVEN COUNTIES PROPERTY LOTS 80,81, AND 82 HAVE BEEN DEEDED TO THE CITY OF HEBRON ESTATES.

MAYOR RICKETTS REPORTED THAT THE STREET SIGN POLES HAVE BEEN INSTALLED. HE HOPES TO HAVE THE PROJECT COMPLETED BY JULY MEETING.

A LONG DISCUSSION WAS HELD REGARDING ANIMALS IN THE CITY. VARIOUS SOLUTIONS WERE DISCUSSED INCLUDING A HOLDING CAGE BE INSTALLED TO HOLD ANIMALS UNTIL THE ANIMAL WARDEN CAN GET THEM.IT WAS ALSO SUGGESTED TO HAVE THE SHERIFF STOP AND TALK TO THE OWNERS. THERE WERE SPECIFIC COMPLAINTS ABOUT TWO DALMATIANS. IT WAS OF GREAT CONCERN THAT WHEN THE RESIDENTS CALL THE ANIMAL WARDEN THEY ALWAYS GET THE ANSWERING MACHINE.
