CITY OF HEBRON ESTATES MEETING

PRESENT: COMMISSIONERS CARDWELL. FRALEY. HANSEN. FRALEY, MAYOR
RICKETTS, CITY CLERK FERGUSON. TOM BARR WITH PIONEER NEWS.ATTORNEY
WOOLDRIDGE WAS ABSENT. NO VISITORS.

THE MEETING WAS HELD IN THE NO.BULLITT H.S. PARKING LOT.

MINUTES: A MOTION WAS MADE BY COMM. RUSSELL AND SECONDED BY COMM. HANSEN TO ACCEPT THE MINUTES AS PRESENTED. MOTION PASSED 4/0.

BUDGET: A MOTION WAS MADE BY COMM. HANSEN AND SECONDED BY COMM. FRALEY TO ACCEPT THE BUDGET AS PRESENTED. MOTION UNANIMOUSLY CARRIED.

A MOTION WAS MADE BY COMM. RUSSELL FOLLOWING A RECOMMENDATION BY THE MAYOR TO GIVE CLERK FERGUSON \$500 FOR THE COMPLETION OF WORK ON PAST TAXES PRIOR TO 1992 INCLUDING THE PLACEMENT OF LEINS ON THOSE PROPERTY OWNERS UNTIL ATTORNEY WOOLDRIDGE TAKES THE OWNERS TO COURT TO COLLECT THE TAXES. MOTION SECONDED BY COMM. CARDWELL. MOTION UNANIMOUSLY CARRIED. CLERK FERGUSON REQUESTED THAT THIS TAKE EFFECT AFTER THE SECOND READING OF THE NEW BUDGET.

OLD BUSINESS: THERE WAS A DISCUSSION ON HOW TO FINE PROPERTY OWNERS WHO WERE NOT MOWING THEIR PROPERTY. IT WAS DECIDED THAT A FINE BE IMPOSED AND A LEIN BE PLACED IF THEY DID NOT PAY THE FINE. MS. FERGUSON QUESTIONED THE LEGALITIES; IT WAS DECIDED TO AWAIT APPROVAL OF THE CITY ATTORNEY.

COMM.FRALEY REQUESTED CLARIFICATION OF JUNK CARS.IT WAS CONSENSUS THAT THE CAR MUST BE MOVED EVERY TEN DAYS AND MUST BE OPERABLE AT ALL TIMES.SHE WILL BE SENT A LETTER REGARDING A CAR THAT HAS NO LICENSE. FOLLOWING A DISCUSSION MS.FERGUSON WAS DIRECTED TO SEND A LETTER REGARDING ORDINANCE OR DEED VIOLATION TO:JOHNSON, WRECKED CAR; ROBARDS, FLAT TIRE; LEE, FLAT TIRE; REDMON, TEMPO INOPERABLE, WEEDS; FRALEY, INOPERABLE CAR:DUNNAVAN, DRAINAGE & LANDSCAPING; BURKE, MOWING; MEREDITH, MOWING.COMM.RUSSELL WILL GET A LIST TO MS. FERGUSON ON THE MOWING ALSO. MS. FERGUSON HAS SENT SOME LETTERS ALREADY.COMM. RUSSELL WILL CONTACT THE OWNER ABOUT A GARAGE NOT HAVING A BRICK FRONT.

NEW BUSINESS: THE FIRST READING OF THE 1996-1997 BUDGET WAS HELD.

COMM.HANSEN LED A DISCUSSION ON THE RECENT TORNADO.COMM.HANSEN MOVED THAT WE CONTACT RUTH CHOWNING AND CONTRIBUTE \$1000.00 TO TORNADO RELIEF TO BE GIVEN DIRECTLY TO DISASTER VICTIMS IN NORTH BULLITT. SECONDED BY COMM. RUSSELL. MOTION CARRIED 3/0 WITH CARDWELL OPPOSING.

COMM. RUSSELL MADE A MOTION, SECONDED BY COMM. HANSEN THAT A LETTER BE SENT TO MAYOR WELKER IN PIONEER VILLAGE TO RELOCATE THE ROAD SIGN ON EAST PRESTON HWY. TO WEST PRESTON HWY. THE SIGN CAUSED CONFUSION FOR RESIDENTS OF HEBRON ESTATES DURING THE RECENT TORNADO AS THE POLICE AND ARMY DECLARED US IN THE PIONEER VILLAGE ZONE. MOTION CARRIED.
