

CITY OF HEBRON ESTATES MEETING
JUNE 27, 2000

PRESENT: COMM. MURPHY, FRALEY, TUCKER, COMM. RUSSELL, MAYOR RICKETTS, ATTORNEY EDISON, ETHICS COMMISSIONER PULLIAM, CLERK FERGUSON, MR. BARR PIONEER NEWS AND SEVEN GUESTS. ABSENT WAS PLANNING & ZONING REP. GERALD BURKE.

MINUTES: COMM. TUCKER MADE THE MOTION TO ACCEPT THE MINUTES AS PRESENTED; SECONDED BY COMM. FRALEY; MOTION PASSED.

BUDGET: COMM. TUCKER MOVED TO PAY THE BILLS; SECONDED BY COMM. MURPHY; PASSED 3/0.

OLD BUSINESS: SECOND READING OF ORDINANCE 2000-02 ; ANNUAL BUDGET FOR 2000-2001 BY ATTORNEY EDISON. A MOTION WAS MADE BY COMM. FRALEY TO PASS THE ORDINANCE; SECONDED BY COMM. MURPHY; PASSED 3/0.

SECOND READING OF ORDINANCE 2000-03 TO CHANGE THE REGULAR TIME AND DATE OF THE REGULAR MONTHLY MEETING TO THE FIRST TUES. NIGHT AT 7:00P.M. WAS COMPLETED BY ATTORNEY EDISON; A MOTION TO PASS THE ORDINANCE WAS MADE BY COMM. MURPHY AND SECONDED BY COMM. TUCKER; PASSED 3/0.

SECONDED READING OF ORDINANCE 2000-04 5% INSURANCE TAX ON PROPERTY WAS CONDUCTED BY ATT EDISON . MOTION WAS MADE COMM. MURPHY AND SECONDED BY COMM. FRALEY; MOTION PASSED 4/0.

COMM. FRALEY AND MURPHY CONDUCTED A DISCUSSION ABOUT AN ARTICLE IN PIONEER NEWS AND COURIER JOURNAL REGARDING JUDGE WALLER AWARDED IN FAVOR OF THE COUNTY ON ROADS IN PIONEER VILLAGE. ATTORNEY EDISON REQUESTED THE COUNTY DISCONTINUE THE ROADS AND THE COUNTY JUDGE REFUSED. ATTORNEY INFORMED THAT THE 1994 LEGISLATURE PASSED A LAW THAT BEFORE SCHOOLS CAN BE BUILT A ROAD PLAN HAS TO BE SUBMITTED AND THE D.O.T IS IN CONTROL OF ROAD PLAN.

MAYOR RICKETTS REPORTED THE TURNING LANE AT E. HEBRON LANE WILL BE STARTED SOON ACCORDING TO REP. BELCHER. IT WAS GENERAL CONSENSUS THAT IT SHOULD BE COMPLETED BEFORE SCHOOL STARTS.

COMM. FRALEY MOVED THAT ALL SPEED LIMITS IN CITY OF HEBRON ESTATES BE 25 MPH; SECONDED BY COMM. MURPHY. MOTION PASSED 4/0.

ATTORNEY EDISON REPORTED THAT DELINQUENT TAXES ARE IN THE COLLECTION PROCESS.

RESIDENT MIKE IDLA WANTED TO KNOW WHY WE DIDN'T HAVE TO VOTE AS A CITY TO THE FORM OF GOVERNMENT IN THE CITY. THE CITY BEGAN AS A MAYOR AND 6 COUNCIL MEMBERS , THEN BECAME A 6TH CLASS CITY AND WENT TO FOUR COMMISSIONERS. COMM. FRALEY STATES THAT THE CITY OF ANY CLASS CAN CHOOSE TYPE OF GOVERNMENT.

NEW BUSINESS: COMM. MURPHY WAS CONCERNED ABOUT THE QUARRY EXPANDING TO UNDERGROUND MINING IN OUR CITY. ATTORNEY EDISON INFORMED THAT UNDERGROUND MINING CANNOT CROSS PROPERTY LINES THEREFORE THE QUARRY MUST OWN PROPERTY TO UNDERGROUND MINE AND WE HAVE NOTHING TO WORRY ABOUT.

CONCERNS THAT A FIREMAN IN A RED EXPLORER DRIVES AT EXCESSIVE SPEEDS DOWN BURKLAND BLVD. CLERK INSTRUCTED TO SEND A LETTER THE ZONETON FIRE CHIEF.

THE ISSUE OF WHETHER THE CITY SHOULD HAVE CITY POLICE WAS DISCUSSED. COMM. FRALEY STATED SHE HAD SPOKEN WITH FIVE OF HER NEIGHBORS AND THEY DID NOT WANT POLICE. CLERK FERGUSON STATED SHE DID NOT CALL THE COMMITTEE MEETING BECAUSE IT WOULD HAVE BEEN HER AND TIM SANDERS MEETING. MAYOR RICKETTS STATED THAT IT WILL BE DISCUSSED LATER
RANDY VINCENT, PROPERTY OWNER REQUESTED THAT THE HEBRON CEMETARY FENCE LINES BE CLEANED. COMM. MURPHY MOVED THAT A LETTER OF VIOLATION BE SENT TO HEBRON CEMETARY TO CLEAN OUT THE FENCE ROWS ; SECONDED BY COMM. FRALEY; MOTION PASSED.

MOTION WAS MADE BY COMM. FRALEY TO ADJOURN; SECONDED BY COMM. MURPHY; PASSED. NEXT MEETING
