CITY OF HEBRON ESTATES JULY 2, 2002

PRESENT: MAYOR RICKETTS, COMMISSIONERS FRALEY, MURPHY, TUCKER, CLERK HURST AND PIONEER NEWS SARAH BAKER AND 3 GUESTS.

MINUTES: MOTION WAS MADE BY COMM. TUCKER AND SECONDED BY COMM. MURPHY; MOTION PASSED 3/0.

BILLS: CLERK HURST TOLD THE COUNCIL THAT THE CITY PURCHASE A FAX MACHINE, NEW PHONE AND \$350.00 FOR MOWING OUR LOTS AND \$135.00 THE BURKE PROPERTY. MOTION WAS MADE BY COMM. TUCKER AND SECONDED BY COMM. FRALEY; MOTION PASSED 3/0.

OLD BUSINESS: MAYOR RICKETTS TALKED ABOUT THE BURKE'S MOWING VIOLATION. THE BURKE PROPERTY HAS BEEN MOWED AND A CERTIFIED LETTER WITH A RECEIPT WILL BE SENT OUT FOR REIMBURSEMENT TO THE CITY FOR CUTTING THE GRASS.

COMM. MURPHY CALLED MR. BURKE ABOUT FARO CIRCLE. MR. BURKE SAID THAT HE WOULD BRING IT UP TO SPECK AND THAT THE COUNTY WAS ALREADY PAVING IT. HE ALSO TOLD HER THAT THE LAST TIME IT WAS PAVED WAS WHEN THE CITY PAVED IT AND I DID NOT ASK THEM TO PAVE IT. HE SAID WHY SHOULD HE HAVE TO PAY FOR ANYTHING IF THE CITY PAVED IT THE FIRST TIME. COMM. MURPHY ASKED THE COUNCIL "WHY DID WE PAVE IT". MAYOR RICKETTS SAID THAT IT WAS PROBABLY A MISTAKE. COMM. MURPHY SAID THAT PRETTY MUCH NOTHING WAS GOING TO CHANGE.

CLERK HURST GAVE SOME UPDATES ON VIOLATION LETTERS THAT SHE SENT OUT. SHE TOLD THE COUNCIL THAT SHE STILL HAD NOT RECEIVED THE SIGN PERMIT PAYMENTOF \$70.00 FOR THE BULLARD'S MUFFLER SHOP. SHE SAID THAT SHE WILL PROBABLY HAVE TO FILE A COMPLAINT.

THE SECOND THING WAS THAT CLERK HURST WAS GOING TO SEND OUT THE RECEIPT FOR THE MOWING VIOLATION FROM THE BURKE PROPERTY. MAYOR RICKETTS ASKED THAT THE CLERK TALK TO MARK EDISON ABOUT SENDING THE RECEIPT FIRST.

CLERK HURST BROUGHT UP THE DIFFERENT DESIGNS AND ESTIMATES FOR THE CITY SIGN. SHE ASKED FOR FEEDBACK ON SOME IDEALS FOR THE CITY'S SIGN. COMM. MURPHY LED A DISCUSSION ON THE IMPORTANCE OF HAVING A SIGN. SHE SUGGESTED HAVING THE ADDRESS, NAME, AND PHONE NUMBER. MAYOR RICKETTS SAID THAT HE WOULD GET WITH MARC KISER ABOUT PUTTING UP A SIGN AND IF SO OUT IN FRONT.

NEW BUSINESS: COMM. TUCKER TALKED ABOUT WATER PRESSURE PROBLEMS THAT HE WAS EXPERIENCING. HE STATED THAT HE WAS GOING ATTEND THE WATER COMPANY MEETING ON JULY 9TH TO SEE IF ANYONE ELSE WAS EXPERIENCING THE SAME PROBLEM. HE EXPLAINED THAT HIS WATER PRESSURE WAS SO BAD THAT HIS SPRINKLER COULD NOT EVEN SHOOT WATER AROUND.

MOTION WAS MADE TO ADJOURN BY COMM. MURPHY AND SECONDED, COMM. TUCKER; PASSED 3/0.
