CITY OF HEBRON ESTATES MEETING

**PRESENT:** COMMISSIONER FRALEY, HANSEN, MURPHY; MAYOR RICKETTS, ATTORNEY EDISON, CLERK FERGUSON, PLANNING & ZONING REP. BURKE, MR. BARR PIONEER NEWS, MR. PULLIAM ETHIC COMMISSIONER, MAYOR BROWN-FOX CHASE; AND SIX GUESTS. COMM. RUSSELL WAS ABSENT.

**MINUTES:** COMM. HENSON MOVED TO ACCEPT THE MINUTES AS PRESENTED AND COMM. MURPHY SECONDED. PASSED 3/0.

**BUDGET:** COMM. FRALEY MOVED TO ACCEPT AS PRESENTED AND PAY THE BILLS CONSISTING OF LGE, ALLTEL, ATTORNEY, MOWING AND ETC. MOTION WAS SECONDED BY COMM. HENSON. PASSED 3/0.

**OLD BUSINESS:** NONE

**NEW BUSINESS:** MOTION WAS MADE BY COMM. HANSEN AND SECONDED BY COMM. MURPHY TO HAVE ART HENSON COMPLETE THE YEARLY AUDIT. MOTION PASSED 3/0.

MAYOR AND CLERK WILL RIDE THE CITY FOR VIOLATIONS. SOME VIOLATIONS SENT ON MAY 10 HAVE NOT BEEN TAKEN CARE OF AND MAY NEED TO HAVE COMPLAINTS TAKEN WITH WALT SHOLAR.

COMM. MURPHY QUESTIONED THE INSTALLATION OF THE SIGN AT THE MODEL HOME ON BURKLAND. CLERK FERGUSON REPORTED THE PERMIT HAD BEEN PURCHASED AND THE PLANS WERE WITHIN THE GUIDELINES IN THE ORDINANCE.

JERRY BURKE WAS CONCERNED IF THE OFFICIALS WERE SATISFIED WITH THE JOB HE WAS DOING FOR THE CITY. HE HAD A LETTER CONCERNING AN ADULT DAY CARE THAT WAS SENT TO THE GOVERNOR ON CITY LETTERHEAD AND WHY HE DIDN'T KNOW ANYTHING ABOUT IT. THE LETTER WAS WRITTEN TO GATHER INFORMATION FOR THE CITY GRANT BEING CONSIDERED AT THE TIME FOR THE SENIOR CITIZENS BUILDING. MAYOR RICKETTS WAS AWARE OF THE LETTER. MS. FERGUSON HAS SINCE DECIDED TO START A PRIVATE ADULT DAY CARE IN HILLVIEW. A COPY OF THE LETTER WITH LETTERHEAD WAS GIVEN TO PLANNING AND ZONING FOR THEM TO GET KRS NUMBERS AND PHONE NUMBERS. CLERK FERGUSON TOLD MR. BURKE IF HE HAD QUESTIONS, HE SHOULD HAVE CALLED HER AS HE HAS DONE MANY TIMES PREVIOUSLY.

MR. PULLIAM ASK ABOUT INFORMATION PLACED IN HIS MAILBOX WHERE SOMEONE PROPOSED TO ANNEX WITH PIONEER VILLAGE. ACCORDING TO ATTORNEY EDISON THAT CANNOT HAPPEN AT THIS TIME.

COMM. HANSEN MOVED TO ADJOURN; SECONDED BY COMM. FRALEY. PASSED 3/0.
