Present: Mayor Clark, Commissioners Allen, Forshee, Murphy, Tucker, Clerk Picheo, Tom Barr from the Pioneer News and 9 guests.

Minutes: Motion to approve July1, 2008 minutes with the following correction: to include \$.16 a foot for striping of the road. Motion was made to approve the minutes with one correction was made by Comm. Tucker and seconded by Comm. Forshee; Passed 4/0.

Budget: Motion to pay the regular monthly bills was made by Comm. Murphy and seconded by Comm. Tucker; Motion Passed 4/0.

Garbage Bids: Atty. Edison opened the bids for the Garbage Collection for the city. Atty. Edison read a notice from ID who chose not to give a bid at this time. Atty. Edison read the bid from Waste Management which included a 4 year contract at a rate of \$10.90 and a homestead discount of \$10.00. Atty. Edison read a bid for Rumpke which included a 4 year contract one free tote, and a rate of \$10.25 to \$10.75. Comm. Tucker asked Rumpke if they were still going to offer unlimited cans and Michael said "yes". Mayor Clark asked both companies, if a provision was included in the bid that addressed the large number waste bins for commercial use due to the city's ordinance regarding enclosed dumpsters. Mike from Rumpke replied that if awarded they would comply with the ordinance and would work with the city to address the situation. Comm. Tucker asked if either would pick up large items and both said "yes". Mayor Clark asked the council if they wanted to have a special meeting and the council agreed. Mayor Clark announced that a special meeting would take place on August 12 to review and approve the garbage bids.

Officer Cook Report: Officer Cook reported a total of 40 hours for patrol time for both officers for the month of July with a total of 21 contacts and 17 visits /"tours".

Old Business: Atty. Edison explained to the council that the city does not have an inter-local agreement with the county for storm water run off.

Atty. Edison explained that the taxes should be certified by the middle of August.

Clerk Picheo gave a report on the Yard Sales monies. Clerk Picheo explained that we have a total of \$191.47 dollars that have not been used. Clerk Picheo stated that we may not have to collect money for the next publication.

Mayor Clark led a discussion on the news letter publications. Mayor Clark stated that due to the lack of information the news letter will be sent out one time a year. Several residents spoke up that they enjoy reading them and one stated that he has kept every one. Comm. Murphy stated that a news letter will be going out soon and if anyone has any information to please let her know.

Comm. Murphy led a discussion on 3511 Burkland Blvd. Atty. Edison stated that he did send a letter to the Board of Health. Comm. Murphy stated that should she advise Kevin to send a letter once a week to the Health Department to address the situation. Atty. Edison stated that a form letter does not get as much attention as one from several different people.

Comm. Murphy led a discussion on 3507 Burkland Blvd. regarding the brush pile. Mayor Clark stated that he talked to Bradley Warren and told him to dispose of the pile. Mayor Clark also told him to contact the fire department to see if he could burn.

Comm. Murphy led a discussion on landscaping the Community Center sign. The council agreed to leave the sign as is.

Comm. Murphy asked the council about the stream walk. Mayor Clark did not know any information.

Atty. Edison stated that Bullitt County will be having community walk that will start at Little Flock and will go back and forth for 3 hours to Mc Donald's on October 2nd. 13 94
