

**CITY OF HEBRON ESTATES REGULAR MONTHLY MEETING
AUGUST 7, 2001**

PRESENT: MAYOR RICKETTS, ATTORNEY EDISON, COMMISSIONERS: FRALEY, MUIR, MURPHY, TUCKER, MR. BARR PIONEER NEWS, JENNIFER HURST FOR MARTHA FERGUSON CITY CLERK WHO WAS ABSENT AND 5 GUEST.

MINUTES: MOTION WAS MADE BY COMM. MURPHY AND SECONDED BY COMM. FRALEY TO ACCEPT THE MINUTES AS PRESENTED. PASSED 4/0.

OLD BUSINESS: COMM. FRALEY LED THE DISCUSSION ON THE PROGRESS OF THE NEW BUSINESS OFFICE. MAYOR HOPES TO BE MOVED IN AFTER SEPT. 1.

COMM. FRALEY LED A DISCUSSION ON THE HEBRON ESTATES LOTS AND SHOULD WE SELL SOME OF THEM. IT WAS QUESTIONED IF ANY OF THE LOTS HAD BEEN PERKED.
