Present: Mayor Clark, Commissioners Allen, Forshee, Murphy, Tucker, Clerk Picheo, Tom Barr from the Pioneer News and 9 guests.

Minutes: Motion to approve August 5, 2008 minutes with the following corrections: to change "move" to "on loan" with reference to the monies taken from the general account, change the verbiage for the motion from the word "move" to "loaned from general account", replace "Michael" with "Rumpke Representative", and change the date from October 2nd to October 12th with regards to the date of the walk. Motion was made to approve the minutes with the corrections was made by Comm. Murphy and seconded by Comm. Tucker; Passed 4/0.

Motion to approve Special Meeting Minutes for August 12, 2008 was made by Comm. Tucker and seconded by Comm. Forshee; Passed 4/0

Budget: Clerk Picheo explained the new layout (black for income and red for expenses) for the monthly budget statements. Motion to pay the regular monthly bills was made by Comm. Forshee and seconded by Comm. Murphy; Motion Passed 4/0.

Officer Cook Report: Officer Cook worked a total of 25 hours for the month of August with a total of 12 visits / tours with 9 contacts. Officer Cook stated that other than some parking issues with the school it has been quite. Comm. Murphy informed Officer Cook that she has received some concerns regarding students parking on Willow Way.

Officer Waters Report: Officer Waters stated that he worked a total of 15 hours for the month of August with a total of 9 visits and 11 contacts. The officer reported on a speeder on Ruby Way. Comm. Murphy stated that the word is out that tickets are being issued instead of "warnings".

Old Business: Judy Gardner from "Taste of Bullitt County" came to announce the event has been cancelled until spring of 2009. She gave a quick overview of what to expect at the event and also reminded residents to participate in the upcoming walk on October 12th from 2-5 pm between Tanyard Springs and Mc Donald's on Preston Hwy sponsored by the U of K Agricultural Department.

Mayor Clark reminded everyone that the stream walk will take place on November 1st. Everyone will meet at the same place from last year will be at the old Winn Dixie parking lot.

Mayor Clark read a letter from CK's market regarding the explanation to why the portable sign was moved from its original position. They explained that due to the problem with people driving through the lot the sign was moved at one of entrances to help cut down on the number of cut-thrus. The letter asked the council to allow for the sign to be moved backed to its original location without penalty. Motion was made by Comm. Forshee to allow CK's market to return the sign to its original location and anchoring and seconded by Comm. Tucker; Passed 4/0.

Comm. Murphy led a discussion on a conversation with Riley Stucker with the EPA regarding the burning at 3507 Burkland Blvd. Comm. Murphy stated that the property owner had left while the pile was burning, 2x4's, plastic, wood and paper. Comm. Murphy said that Mr. Stucker told her that no matter what the Dept of Forestry says during a no attainment (May - October) you cannot burn. Comm. Murphy stated that the EPA did try and contact Mr. Warren (the property owner) to no avail and has not returned their message. Mayor Clark stated that he did tell Mr. Warren to contact the fire department and Mr. Warren did contact the Mayor to let him know that he was contacted by the EPA about the approved burning through the fire department.

A resident asked if the city had an ordinance regarding parking an RV at your house. The council all spoke up and said, "no".

Atty. Edison read the 2nd reading on Ordinance 2008-03 Property Tax Rate for Real Property. Motion to approve Ordinance 2008-03 Property Tax Rate for Real Property with the tax rate of .091 per \$100 was made by Comm. Allen and seconded by Comm. Forshee Passed 4/0.

Atty. Edison read the 2nd reading on Ordinance 2008-04 Tax Rate for Public Service Companies. Motion to approve Ordinance 2008-04 Property Tax Rate for Public Service Companies with the tax rate of .091 per \$100 was made by Comm. Allen and seconded by Comm. Forshee Passed 4/0.

New Business:

Mayor Clark led a discussion regarding filing a claim with LG& E on the street repair. He explained that it is still pending.

Mayor Clark gave a reminder that the Louisville Water company has been updating residents' water meters. Motion to adjourn the meeting was made by Comm. Murphy and seconded by Comm. Tucker Passed 4/0. Meeting adjourned 8:00 p.m.
