PRESENT: MAYOR RICKETT'S, COMMISSIONERS MUIR, MURPHY, TUCKER,
ATTORNEY EDISON, CLERK HURST AND PIONEER NEWS SARAH BAKER AND 5
GUESTS.

MINUTES: MOTION WAS MADE BY COMM. TUCKER AND SECONDED BY COMM.
MURPHY; MOTION PASSED 3/0.

BILLS: MOTION WAS MADE BY COMM. TUCKER AND SECONDED BY COMM.

OLD BUSINESS: MAYOR RICKETT'S TOLD THE COUNCIL THAT THE GREEN CITY
SIGN ON PRESTON HIGHWAY HAD BEEN PUT UP. HE ALSO STATED THAT THE
HOLE ON SCENIC TRAIL HAD BEEN FILLED. MAYOR RICKETT'S HAD ALSO TOLD
THE COUNCIL THAT HE HAD MOVED SOME SIGNS THAT WERE PLACED NEAR THE
CEMETERY.

MAYOR RICKETT'S LED A DISCUSSION ON THE BURKE'S PROPERTY. HE TOLD
THE COUNCIL THAT WE DID RECEIVE THE \$135.00 FOR THE MOWING FOR THE
TWO PROPERTY'S ON EAST HEBRON LANE. COMM. MUIR ASKED ABOUT THE
BURKE'S PROPERTY WITH THE TRAILERS ON IT. COMM. MURPHY REMINDED
THE GROUP THAT WE WERE GOING TO GIVE THE BURKE'S A 6 MONTH GRACE
PERIOD DUE TO THE CONVERSATION WITH COMM. MURPHY. THE COUNCIL
AGREED THAT A LETTER WILL BE SENT TO THE BURKE'S ON NOVEMBER 1, 2002.

COMM. TUCKER ASKED IF THE CITY HAD RECEIVED A SIGN PERMIT FOR THE
CARPET STORE SIGN. CLERK HURST SAID NO. SHE EXPLAINED THAT SHE WAS
GOING TO CALL THEM AND /OR SEND THEM A LETTER ABOUT TAKING DOWN
THE SIGN. CLERK HURST ALSO EXPLAINED TO THE GROUP ABOUT RECEIVING
\$35.00 FOR THE MUFFLER SHOP SIGN INSTEAD OF THE AGREED AMOUNT WITH
JERRY WEBB OF \$75.00. SHE EXPLAINED THAT THE REASON WHY THEY DID NOT
SEND THE \$75.00 IS BECAUSE THEY SAID THAT THEY TOOK DOWN ONE SIGN AND
JUST REFACED ANOTHER.

CLERK HURST LED THE DISCUSSION ON THE CITY SIGN FOR THE BUILDING. THE
COUNCIL AGREED THAT THEY WOULD LIKE TO SEE THE SIGN BE PUT UP BY
NOVEMBER 1, 2002. THIS WOULD HELP DURING THE TAX SEASON.

COMM. MURPHY LED A DISCUSSION ON THE LIGHTS ON WILLOW WAY. SHE
EXPLAINED THAT THEY WERE IN DESPERATE NEED OF PAINT. SHE SAID THAT
SHE CONTACTED LG& E. LG&E TOLD HER THAT HER REQUEST WOULD BE PUT
ON A WAITING LIST AND THEY WOULD NOT BE ABLE TO GET TO IT BEFORE THE
FIRST OF NEXT YEAR.

COMM. TUCKER TOLD THE GROUP THAT INSIGHT CABLE COMPANY WOULD BE
INSTALLING A GREEN BOX IN THE CITY AND COULD BE PLACED ANYWHERE
NEAR A TELEPHONE POLE. THIS BOX SHOULD HELP PEOPLE RECEIVE THE AT&T
TELEPHONE / DSL HOOK UP FOR THEIR COMPUTER.

NEW BUSINESS: ATTORNEY EDISON READ THE FIRST READING OF THE
PROPOSED TAX RATE ORDINANCE.

HE ALSO GAVE CLERK HURST THE COPY THE FIRST COPY \ DRAFT OF THE TAX INFORMATION FROM THE PVA OFFICE.

CLERK HURST TOLD THE COUNCIL THAT SHE HAD RECEIVED THE TAXES FOR THE PARK'S PROPERTY. SHE ALSO REMINDED THE GROUP THAT THE CITY STARTED OFF WITH 14 LIENS FOR UNPAID PROPERTY TAXES AND WE ARE DOWN TO 7.

CLERK HURST ASKED THE CITY IF WE COULD GET BOTH A PRINT OUT AND AN ELECTRONIC VERSION OF THE PROPERTY FROM THE PVA OFFICE. THE COUNCIL AGREED THAT IT SOUNDED LIKE A GOOD IDEA. SHE ALSO TOLD THE COUNCIL THAT WE NEED TO GET A REPLACEMENT SIGNATURE FOR THE CHECKING ACCOUNT TO REPLACE MILLIE. THE COUNCIL SUGGESTED KRISTINA. KRISTINA AGREED.

COMM. MURPHY LED A DISCUSSION ON THE NOISE ORDINANCE. SHE EXPLAINED THAT SHE HAD RECEIVED SOME PHONE CALLS REGARDING NOISE FROM MR. BERNARD'S YARD. THE RESIDENTS COMPLAINED THAT IT WAS DUE TO THE FOOTBALL PRACTICE. COMM. MURPHY EXPLAINED THAT SHE HAD TALKED TO THE PROPERTY OWNER ABOUT THE SITUATION AND HE DID MOVE THE TEAM TO THE OTHER SIDE OF HIS PROPERTY HOWEVER, IT STILL DOES NOT TAKE CARE OF THE PROBLEM. COMM. MURPHY SAID THAT YOU CAN NOT EVEN SET OUT ON YOUR BACK PORCH WITH OUT HEAR ALL THE NOISE. THE QUESTION WAS RAISED IF THEY WERE KIDS FROM OUR AREA IF NOT, THAN THEY NEEDED TO GO PRACTICE SOME WHERE ELSE.

A DISCUSSION WAS LED BY A GUEST WHO HAD A PROBLEM WITH THE VANDALISM ON WILLOW WAY. HE SAID THAT HE HAS HAD HIS CONCRETE STATUS TORN UP AND EVEN HIS DOG HAS BEEN ABUSED. HE WANDERED IF THE CITY COULD DO ANYTHING AND IF THE CITY WAS GOING TO GET A LAW ENFORCER. COMM. MURPHY SAID THAT SHE HAD HEARD ABOUT THE PROBLEM BUT DID NOT KNOW THAT IT WAS THAT BAD. SEVERAL COUNCIL MEMBERS TOLD HIM THAT HE NEED TO CONTACT THE SHERIFF'S OFFICE EVERY TIME HE SAW SOMETHING SUSPICIOUS.

MOTION WAS MADE TO ADJOURN BY COMM. MUIR AND SECONDED COMM. MURPHY; PASSED 3/0.
