OLD BUSINESS: ATTORNEY EDISON CONDUCTED THE SECOND READING OF ORD. 2001-04. MOTION WAS MADE BY COMM. FRALEY AND SECONDED BY COMM. TUCKER TO PASS ORD.2001-04 WITH THE TAX RATE OF 10.6 PER \$100 PROPERTY ASSESSMENT. PASSED 3/0 WITH MAYOR VOTING..

ATTORNEY EDISON CONDUCTED THE SECONDED READING OF ORD. 2001-05 WITH SERVICE TAX RATE OF 10.6 PER \$100 PROPERTY ASSESSMENT. MOTION MADE BY COMM. TUCKER TO PASS THE ORD. AS READ; SECONDED BY COMM. TUCKER; PASSED 3/0 WITH MAYOR VOTING.
