## THE CITY OF HEBRON ESTATES OCTOBER 4, 1994

Minutes of the Commissioners Meeting. MET OUTSIDE IN THE PARKING LOT OF THE KENTUCKY TURNPIKE WATER DISTRICT BUILDING.

PRESENT: MAYOR RICKETTS, COMMISSIONERS CARDWELL, FRALEY, HANSEN, MARSHALL, CITY CLERK MARTHA FERGUSON, MR. BARR; PIONEER NEWS, MR. JOHN WOOLRIDGE; ATTORNEY, AND ONE VISITOR, MR. RUSSELL.

MINUTES: A MOTION WAS MADE BY COMMISSIONER CARDWELL AND SECONDED BY COMMISSIONER HANSEN TO APPROVE THE MINUTES AS CORRECTED FOR ORDINANCE #940-02 REGARDING THE TAX RATE. MOTION PASSED.

BUDGET: COMMISSIONER MARSHALL MOVED TO PAY THE REGULAR BILLS SECONDED BY COMMISSIONER CARDWELL; MOTION CARRIED.

OLD BUSINESS: MR. WOOLRIDGE REPORTED THAT HE SENT THE LETTER TO THE RESIDENCE ON BURKLAND BLVD REGARDING THE DEBRIS,OLD CARS AND ETC. HOWEVER, THE YARD HAS BEEN CLEANED BUT THE BROWN CAR CONTINUES TO BE KEPT IN THE BACK YARD.

COMMISSIONER HANSEN HAS DECIDED TO USE THE QUESTIONAIRE AND SURVEY IN HIS CAMPAIGN FOR COMMISSIONER. HE WILL PAY FOR THE COPYING AND DISTRIBUTE THEM PERSONALLY.

MR. WOOLRIDGE INFORMED THE COUNCIL THAT THE RESOLUTION ADOPTED AT THE SEPTEMBER MEETING, REGARDING THE PLANNING AND ZONING 940T, WILL HAVE TO BE ADOPTED VIA AN ORDINANCE. THE FIRST READING OF THE ORDINANCE WILL BE AT THE NOV. MEETING.

NEW BUSINESS: TAX BILLS MAY BE LATE ARRIVING TO THE PROPERTY OWNERS SINCE THE ORDINANCE READS THAT THE DUE DATE WILL BE THE SAME AS THE COUNTY BILLS. COUNTY TAX BILLS ARE LATE DUE TO FIRE DISTRICT TAX RATE AND ETC.MS. FERGUSON HAS ORDERED STAMPED WINDOW ENVELOPES.IF THE TAX BILLS ARE NOT OUT BY NOV.1 THE PENALTY DUE DATE WILL BE EXTENDED.

MR. WOOLRIDGE REPORTED THAT ONCE A CITY PASSES ORDINANCES THE COUNTY ATTORNEYS OFFICE MUST PROSECUTE THE CASE. MAYOR RICKETTS STATED THAT MOST OF OUR RESIDENTS SEEM TO UNDERSTAND THE PROCEDURE TO ENFORCE THE ORDINANCES.

MR. WOOLRIDGE PRESENTED THE ETHIC ORDINANCE WHICH IS DUE JAN.1,1995. THE FIRST READING WILL BE AT THE NOV. MEETING. A BOARD OF 3-5 RESIDENTS WILL NEED TO BE APPOINTED AND THE CITY WILL BE OBLIGATED TO PAY THEIR EXPENSES.

MAYOR RICKETTS WILL BE RESPONSIBLE TO INSTALL SPEED LIMIT SIGNS. BURKLAND BLVD AND HEBRON LANE ARE 35MPH. ALL CITY STREETS ARE 25 MPH.

MR. RUSSELL REPORTED THAT THE DOBERMAN DOG ON BURKLAND HAS BEEN REMOVED. THE DOG APPARENTLY BIT TWO CHILDREN.
