CITY OF HEBRON ESTATES MEETING

NOV. 23, 1999

PRESENT: COMMISSIONERS FRALEY, MURPHY, AND RUSSELL ; MAYOR RICKETTS, CLERK FERGUSON, ATTORNEY EDISON, MR. BARR PIONEER NEWS, AND TWO GUESTS. ABSENT WAS COMM. HANSEN AND PLANNING AND ZONING REP. BURKE.

MINUTES: COMM RUSSELL MOVED TO ACCEPT THE MINUTES AS PRESENTED AND COMM. MURPHY SECONDED; MOTION CARRIED.

BUDGET: COMM. FRALEY MOVED TO PAY THE ROUTINE BILLS AND SALARIES; SECONDED BY COMM. RUSSELL; MOTION CARRIED.

OLD BUSINESS: MAYOR REPORTED THAT WE WOULD GET THE TURNING LANE AT E. HEBRON AND PRESTON BUT NOT SURE WHEN DUE TO ASPHALT PLANTS CLOSING. FISCAL COURT APPROVED THE INTERLOCAL AGREEMENT.

ATTORNEY EDISON STATED THAT SOME OF THE PAST TAXES WERE BEING TAKEN TO COURT ON DEC. 10, 1999.

NEW BUSINESS: ATTORNEY HELD THE FIRST READING OF ORD. # 99-04 REPAIR OF STREETS MAINTAINED BY HEBRON ESTATES DISCUSSION FOLLOWED --IF A PERSON TEARS UP A STREET THEY WILL PAY FOR IT.

ATTORNEY EDISON HELD THE FIRST READING OF THE RESOLUTION #99-01 PETITIONING FISCAL COURT FOR THE CITY OF HEBRON ESTATES TO MAINTAIN AND CONTROL BURKLAND BLVD. SCENIC TRAIL AND SCENIC DRIVE. COMM FRALEY MOVED TO APPROVE RESOLUTION 99-01 AND COMM. RUSSELL SECONDED. DISCUSSION FOLLOWED. VOTES ON THE MOTION WERE : COMM. RUSSELL SUSTAINED; MURPHY VOTED NO; FRALEY YES; MAYOR BROKE THE TIE VOTE BY VOTING YES .

MAYOR WILL GET PRICES TO BEGIN BLACKTOPPING IN THE CITY IN THE SPRING.

COMM. RUSSELL WANTS CITY TO BECOME A 5TH CLASS CITY WHICH HAS TO BE FILED BEFORE JAN. 1, 2000. ATTORNEY WILL CONTACT STATE REPRESENTATIVE BELCHER. IT WAS GENERAL TO BEGIN THE PROCEEDINGS TO CHANGE TO A 5TH CLASS CITY.
