PRESENT: MAYOR RICKETTS, COMMISSIONERS RUSSELL, FRALEY AND SIX RESIDENTS/GUESTS. ABSENT WAS COMM. CLARK, HANSEN AND CLERK FERGUSON.

MINUTES: MS. FERGUSON WILL PRESENT AT THE JAN. MEETING.

BUDGET: A MOTION WAS MADE TO PAY THE REGULAR BILLS, CONSISTING OF LGE, ALLTEL, SALARIES AND PRINTING.

OLD BUSINESS: MAYOR REPORTED THAT THE BANK SITUATION CONTINUES. HE SAID THAT HE WILL GET WITH THE PRIVATE ATTORNEY GENERAL AND FIND OUT IF THE ROAD IS COUNTY.

MAYOR RICKETTS REPORTED THAT THE HIBBARD CASE WAS IN COURT TODAY. THE CAR IS RUNNING, BOAT IS ALL IN THE BACK YARD. HE POINTED OUT THE SKIDS. MAYOR SAYS WE WILL WORK WITH THE COUNTY ATTORNEY ON THAT. THEY WILL GO BACK TO COURT IN 30 DAYS. COMM. RUSSELL IS TO KEEP WATCH ON THIS PROPERTY.

NEW BUSINESS: MAYOR HATCHETT, FROM PIONEER VILLAGE WAS PRESENT TO OFFER THE CITY OF PIONEER VILLAGE SUPPORT IN GETTING THE INTERSECTION OF EAST HEBRON LANE AND PRESTON WIDENED OR WHATEVER IS NECESSARY. THIS INTERSECTION IS VERY DANGEROUS ESPECIALLY WITH THE SCHOOL BUSES. MAYOR RICKETTS IS GOING TO TRY TO FIND THE DETAILS OF WHO HAS TOLD THE COUNTY NOT TO MAINTAIN THE ROADS ESPECIALLY WHEN THE CHILDREN ARE INVOLVED. MAYOR RICKETTS SAID THE UTILITY COMPANIES ARE WILLING TO MOVE THE POLES. IT WAS GENERAL CONSENSUS THAT HEBRON LANE NEEDS TO BE UPDATED. MAYOR RICKETTS SAID THAT MR. HILLARD, BANK CEO IS WILLING TO WORK WITH US. MR. HATCHETT WILL FIND OUT HOW MANY ACCIDENTS HAVE BEEN THIS INTERSECTION IN THE LAST COUPLE OF WEEKS. FOLLOWING A LONG DISCUSSION, IT WAS GENERAL CONSENSUS TO CONTINUE TO PURSUE THE SITUATION.

SECOND READING OF ORDINANCE 97-06 WAS CONDUCTED BY ATTORNEY MARK EDISON. A MOTION WAS MADE BY COMM. RUSSELL TO APPROVE ORDINANCE 97-06 REGARDING A LOCAL DEPOSIT FRANCHISE TAX; MOTION SECONDED BY COMM. FRALEY; MOTION PASSED.
