MINUTES REGULAR CITY COUNCIL MEETING 7PM, FEBRUARY 2, 2021

Regular City Council Meeting of Hebron Estates, Mayor Jerry Clark called the meeting to order at 7:00pm on January 5, 2021.

Commissioners present Robert Denner, Russell Forshee, James Tucker. and Kathy Merrifield.
Also, in attendance: City Attorney, Mark Edison and City Clerk, Micheale McCauley

- ⚡ City Clerk McCauley read the regular meeting minutes from January 5, 2021. James Tucker made a motion to accept the regular meeting minutes with two date corrections. Robert Denner 2nd the motion. All were in favor. Motion carried.
 - ⚡ James Tucker made a motion to accept the financial report for January 31, 2021. Russell Forshee 2nd the motion. All were in favor. Motion carried.

OLD BUSINESS

- ⚡ James Tucker inquired about the Trucking Company. Attorney Edison stated the City does not have any say to the type of business conducted, that would be due to Bullitt County Planning & Zoning not coming to the City for any restrictions. The former property owner (Zee Medical) did have a variance, which transferred to the new owner.

NEW BUSINESS

- ⚡ James Tucker inquired about the Mayor asking for the City of pay for his supplemental health insurance. City Clerk McCauley explained other Cities do pay for Mayor's insurance when requested and is not an unreasonable request. Kathy Merrifield made a motion to pay for the Mayor's supplemental health insurance. Robert Denner 2nd the motion. All were in favor. Motion carried.
- ⚡ City Clerk McCauley reported there were 23 delinquent property taxes for 2020 which were mailed out as 1st certified delinquent letters to each. The City sends out a courtesy notice of delinquency in January, secondly, the 1st certified delinquent mailing in February then the 2nd certified delinquent mailing in March. If delinquent taxes are still not paid, they will be advertised in the Pioneer News for the sale in April / May. Russell Forshee inquired if there were any multiple bills. City Clerk McCauley stated there were a few. James Tucker states the amount of delinquent bills outstanding seem low. City Clerk McCauley said those amounts could be separate lots of property or businesses.

COUNCIL BUSINESS

- ✦ Mayor Clark will be meeting with Halls Contracting for the estimate of work to possibly be completed on the 1/8 of mile of roadway that is 14'-18' wide to expand to 21' if possible. Attorney Edison estimates that it will take \$100,000 per mile for the roadway in the past.
- ✦ Russell Forshee asked about how the snow removal was going. Mayor Clark stated that it was going good with no complaints.

POLICE BUSINESS

- ✦ In January 2021 there were 137 Calls for Service to Pioneer Village Police Department.
 - 1/7 on Scenic Trail – pregnant female possible under the influence found unconscious was transported to the hospital.
 - 1/7 on Burkland Blvd – call on burglary in progress. Found front door open with no one inside, seemed as nothing was missing.
 - 1/15 on Burkland Blvd – report of a suspicious vehicle driving in neighborhood, sitting in the driveway. Upon the officer's arrival the vehicle was gone.
 - 1/20 on Faro Ct – report of possible drug activity. Pioneer Village will do extra patrols in the area.
 - 1/20 on Garden Dr – report of a white male walking up and down street ringing doorbells. When officers arrived, there was no one around.
 - 1/26 at Preston Hwy and Lodie Ln – someone wrote profanity on and hung beer cans from the stop sign. Officer removed all.
 - 1/29 on Burkland Blvd – report of someone borrowing car and will not return it. Officer advised to contact the County Attorney to file an unauthorized use report.
 - School is back in person on a staggered schedule with no traffic issues.
 - 1/30 Saturday evening a former officer of Pioneer Village was involved in a fatal shooting in Bullitt County. This is still under investigation. Please keep all in your prayers.


PUBLIC BUSINESS

- ✦ James Tucker inquired about what the City is doing with the garbage. Mayor Clark said the City is waiting on Waste Management concerning the current contract.
- ✦ Steve Beyerly inquired about a clean-up lien the City placed his property. City Clerk McCauley will get with him after the meeting.
- ✦ Mayor Clark advised all if you want to renew or get a KY Real ID you can go to Elizabethtown, KY for less than \$50.00 for 8 year.
- ✦ Bullitt County's population is approximately over 80,000 as of the last Census.

- ✦ James Tucker made a motion to adjourn the meeting. Kathy Merrifield 2nd the motion. All were in favor. Motion carried.
