- + City Clerk McCauley read the regular meeting minutes from March 2, 2021. Robert Denner made a motion to accept the regular meeting minutes as read. Russell Forshee 2nd the motion. All were in favor. Motion carried.
- + Russell Forshee made a motion to accept the financial report for March 31, 2021. Robert Denner 2nd the motion. All were in favor. Motion carried

NEW BUSINESS

- + Rebecca Hurst presented Mayor Clark with a plaque dedicated to former City Clerk Jennifer Hurst-Picheo for her 19 years of service. There was a magnolia tree planted at the Hebron Estates Community Center this previous fall. Jennifer's sister and husband spoke about her loving the position as City Clerk.
- + Mayor Clark asked the Commissioners to add City Clerk McCauley as a signer on the accounts at Park Community Credit Union. James Tucker made a motion to add City Clerk McCauley to the accounts at Park Community Credit Union. Robert Denner 2nd the motion. All were in favor. Motion carried.
- + Mayor Clark said residents may have individual yard sales. Acting on the advice of the City Attorney, the City will not sponsor any yard sales.

POLICE BUSINESS
