- → Robert Denner made a motion to accept the financial report for June 30, 2021. Kathy Merrifield 2nd the motion. All were in favor. Motion carried.
- ♣ Mayor Clark hired Nancy J Steele to be in the Office for businesses to obtain their business license on Friday's from 10am-12pm at the Hebron Estates Community Center. The Office will also be open as usual on Tuesdays from 5:30pm-6:30pm.

OLD BUSINESS

4 Mayor Clark read the 2nd reading of Ordinance 2021-02 Business License Fees. James Tucker made a motion to accept Ordinance 2021-02 Business License Fees. Kathy Merrifield 2nd the motion. The vote was 3 for / 1 against / 0 not voting. Robert Denner voted against. Motion carried. Robert Denner said the fee is too much compared to the other Cities. Mayor Clark said it should have been discussed at the first reading if there were questions or concerns. It would cost the city approximately \$1500.00 to change an ordinance.



NEW BUSINESS

- ♣ Chief Reynolds explained that in Pioneer Village there is an ordinance limiting when fireworks can and cannot be set off, which make it easier to take care of Fireworks complaints in the City. Mayor Clark states three days is plenty of time to celebrate and residents need to be mindful of the people who have PTSD. James Tucker said he personally does not like the fireworks but tells his neighbors to do what they like. Mayor Clark read the 1st reading of Ordinance 2021-03 Fireworks.
- ♣ Mayor Clark received the estimate from Berl Williams Landscaping for the tree barrier along the ditch line at the Community Center. The estimate was for 7 15-gallon Arborvitae Green Giant trees planted 30 feet apart with a 1-year warranty for \$1190.00. Berl Williams said there are very few problem with the trees. Robert Denner made a motion to accept the estimate from Berl Williams Landscaping for \$1190.00 for 7 trees. Kathy Merrifield 2nd the motion. The vote was 3 for / 1 against / 0 not voting. Russell Forshee voted against. Motion carried.

COUNCIL BUSINESS

♣ Robert Denner wanted to discuss ordinance 2020-07 on front yard parking to reduce the time allowed from 48 hours down to 24 hours. Russell Forshee made a motion to leave ordinance as is. No second. Not passed due to lack of motion. Mayor Clark says the only way to stop front yard parking is to have a no parking in front yard ordinance.

- → Pioneer Village Police are running radar on East Hebron Lane, the parents dropping off children at the Girl Scout Camp are speeding. Officer Tulipano spoke to employees at the Camp and told them the warning for speeding are over and from now on they will get citations.
- ≠ 6/3 on Scenic Trl a vehicle was stolen from the driveway at night. The keys were left in the unlocked vehicle, had a handgun in front and an AR-15 in the trunk.
- Like the Chief Reynolds is looking for businesses in the city without a business licenses. He is issuing citations along with the ordinance and application to obtain the license.
