- ✚ City Clerk McCauley read the regular meeting minutes from October 5, 2021. Kathy Merrifield made a motion to accept the regular meeting minutes as read. Robert Denner 2nd the motion. All were in favor. Motion carried.
 - ✚ Robert Denner made a motion to accept the financial report from October 31, 2021. Russell Forshee 2nd the motion. All were in favor. Motion carried.

- ✚ Attorney Edison said the Text Amendment 2021T-01 & 2021-02 was given a favorable recommendation by the Bullitt County Joint Planning Commission. He also advises to put on agenda for the next meeting to give the Commissioners time to review the text amendment.

- ✚ Mayor Clark reported several residents have inquired about the installation of sidewalks in the City.
- ✚ Russell Forshee asked about utilities running under sidewalks. Attorney Edison said it depended on if city easement was for utilities.

COUNCIL BUSINESS

- ✚ Russell Forshee asked how the ditch work in the City was going on Burkland Blvd and Scenic Trl. Mayor Clark said it should restart this week provided the weather cooperates.

POLICE BUSINESS

- ✚ Chief Reynolds report for Hebron Estates includes some of the 194 calls for service to the Pioneer Village Police Department.
- ✚ 10/5 at Hillview Motors – report of alarm, turned out to be false.
- ✚ 10/10 on Judy & Vickie Way – report of suspicious vehicle, older maroon car, male got out and stood in the yard at Judy Way. He was gone when officers arrived.
- ✚ 10/11 on E Hebron Ln – report of alarm, turned out to be false.
- ✚ 10/13 on Judy & Vickie Way – report of something burning. Someone was burning in their backyard.
- ✚ 10/13 on Scenic Trl – report of two intoxicated females. Officers calmed them down.

- ✦ New owner of vacant lot at Burkland Blvd and Scenic Trl was looking for restriction on building on lot.




- ✦ Robert Denner made a motion to adjourn the meeting. Kathy Merrifield 2nd the motion. All were in favor. Motion carried.
