**MINUTES REGULAR** CITY COUNCIL MEETING 7PM, DECEMBER 7, 2021

Regular City Council Meeting of Hebron Estates, Mayor Jerry Clark called the meeting to order at 7:00pm on December 7, 2021.

Commissioners present: Robert Denner, Russell Forshee, James Tucker, and Kathy Merrifield.

Also, in attendance: City Attorney, Mark Edison, and City Clerk, Micheale McCauley

Invocation: James Tucker All Recited the Pledge of Allegiance

- ⚡ City Clerk McCauley read the regular meeting minutes from November 2, 2021. Robert Denner made a motion to accept the regular meeting minutes as read. Kathy Merrifield 2<sup>nd</sup> the motion. All were in favor. Motion carried.
- ⚡ Robert Denner made a motion to accept the financial report for November 31, 2021. James Tucker 2<sup>nd</sup> the motion. All were in favor. Motion carried.

## OLD BUSINESS

- ⚡ Commissioners & Mayor Clark discussed work on the ditch behind the Community Center. Mayor Clark said that RLH Rentals will draw up bid and plans for project if the City would pay for project. Attorney Edison said if ARPA Funds are used, and engineer would have to sign off on project along with placing an advertisement in Pioneer News. Mayor Clark asked Attorney Edison to gather information for January's meeting.
- ⚡ Commissioners inquired about the Text Amendments 2021T-01 & 2021T-02. Attorney Edison asked if Commissioner read the two amendments that was provided in November's meeting. Mayor Clark said will discuss at the January meeting after all have read information.
- ⚡ Commissioner Tucker asked about the Robards Apartments' easement at the entrance Mayor Clark will have RLH Rentals look at.
- ⚡ Commissioner Tucker asked about abandoned property managed by Jerry Burke. Attorney Edison explained that Planning & Zoning or the City does not enforce subdivision restrictions but only the neighbors can enforce issues.

## NEW BUSINESS

- ⚡ Kathy Merrifield made a motion to donate \$500.00 to the 2021 Santa's Helper Program. Russell Forshee 2<sup>nd</sup> the motion. All were in favor. Motion carried.
- ⚡ Mayor Clark explained the need for an Interlocal Agreement with Bullitt County Fiscal Court for acquiring salt at a reduced price. This would save the City money through our contractor for salt / snow treatment materials. James Tucker made a motion to enter into an interlocal agreement between the City of Hebron Estates and Bullitt County Fiscal Court for salt/snow treatments materials. Robert Denner 2<sup>nd</sup> the motion. All were in favor. Motion carried.

## COUNCIL BUSINESS

- ⚡ Robert Denner made a motion to increase the Mayor's salary by \$200.00 per month and to increase the Commissioner's salary by \$50.00 per month starting January 2023. Kathy Merrifield 2<sup>nd</sup> the motion. All were in favor except James Tucker. Motion carried.

## POLICE BUSINESS

- ⚡ Chief Reynolds November report for Hebron Estates includes some of the 198 calls for service to the Pioneer Village Police Department.

- ⊕ 11/8 on E. Hebron Ln – North Bullitt HS – report of students walked out of school. Police made sure the students were not being disorderly. School staff took over after two hours so police could leave.
- ⊕ 11/13 on Scenic Trl – report of 31y/o male pulled a knife on caller. Suspect ran off before police arrived.
- ⊕ 11/29 on Burkland Blvd – report of male and female in verbal argument. Officers were able to get them to stop and go inside.
- ⊕ Chief Reynolds thanked all for their donations to the 2021 Santa’s Helper Program, also to Mayor Clark and City Clerk McCauley for help with the roadblocks. The Program was able to help 84 kids have a Christmas this year they may not have had otherwise. We received more donations this year than any other.
- ⊕ Watch for people taking packages off front porches. If you see this happen, please call police immediately.


**PUBLIC BUSINESS**


