- Lity Clerk McCauley read the regular meeting minutes from March 1, 2022. James Tucker made a motion to accept the regular meeting minutes as read. Robert Denner 2nd the motion. All were in favor. Motion carried.
- ↓ Kathy Merrifield made a motion to accept the financial report for March 31, 2022. Robert Denner 2nd the motion. All were in favor. Motion carried.

NEW BUSINESS

- ♣ Attorney Edison read the 1st reading of Ordinance 2022-05 Budget Fiscal Year 2022-2023.
- ▲ Mayor Clark discussed snow removal. Currently the City is paying \$2800.00 a season (December March), the new proposal is same price and the City pay for salt. - Attorney Edison opened the sale for three delinquent properties. The statute allows eleven years to collect and required to wait for one year to foreclose on property. - Robert Denner made a motion to approve the sign permits #68, #69, and #70 issued by Mayor Clark to CK's Market & Gas. James Tucker 2nd the motion. All were in favor. Motion carried.
- ♣ Robert Denner made a motion to approve the sign permit #67 to Breakthrough Concrete Cutting. Kathy Merrifield 2nd the motion. All were in favor. Motion carried.
- ♣ Robert Denner made a motion for the Mayor to approve sign permits without the Commissioners approval. James Tucker 2nd the motion. All were in favor. Motion carried.
- → James Tucker made a motion to approve the request from RLH Rentals LLC to widen the driveway at 3400 Burkland Blvd. Kathy Merrifield 2nd the motion. All were in favor. Motion carried.
- Mayor Clark received two estimates to repair the cracks on Garden Ct. The ongoing issue of roadway cracking is believed to be from the gray slate under road disintegrating causing road to crack. James Tucker made a motion to accept estimate from RLH Rentals LLC for \$7382.00 to repair the cracks in road on Garden Ct. Robert Denner 2nd the motion. All were in favor. Motion carried.
- ♣ Mayor Clark had the Travelers Insurance Company come out along with K & K Roofing to give an estimate from damages the roof on the Community Center Building. James Tucker made a motion for K &

K Roofing to repair the roof on the Community Center building for estimate of \$10,000. Robert Denner 2nd the motion. All were in favor. Motion carried.

Lity Clerk McCauley asked the Commissioners to promptly cash all checks within the month received.

- Robert Denner asked about the apartment's and CK's Market & Gas dumpster enclosures in need of repair. Attorney Edison will send a letter to both.
- ♣ Robert Denner also requested to replace the American Flag in front of the building.
- ♣ James Tucker spoke about parking in the street and residents tearing up yards from vehicles.

- ♣ Run report for March 180 calls for service to the Pioneer Village Police Department and Chief Reynolds report:

- Resident on Willow Way complained on neighbors parking in yard, scraps in front of garage, dangerous dogs enclosed with a cattle fence and finishing the basement.
