MINUTES REGULAR CITY COUNCIL MEETING 7PM, June 7, 2022

Regular City Council Meeting of Hebron Estates, Mayor Jerry Clark called the meeting to order at 7:00pm on June 7, 2022.

Commissioners present Robert Denner, James Tucker, and Russell Forshee. Absent - Kathy Merrifield
Also, in attendance: City Attorney, Mark Edison and City Clerk, Micheale McCauley

Invocation: James Tucker All Recited the Pledge of Allegiance

- ⚡ City Clerk McCauley read the regular meeting minutes from May 3, 2022. James Tucker made a motion to accept the regular meeting minutes with corrections. Robert Denner 2nd the motion. All were in favor. Motion carried.
- ⚡ Robert Denner made a motion to accept the financial report for May 31, 2022. James Tucker 2nd the motion. All were in favor. Motion carried.

OLD BUSINESS

- ⚡ Attorney Edison read Ordinance 2022-04 Impose Payment of License Fee 5% on Insurance Companies to remove the additional 5% premium. Robert Denner made a motion to accept Ordinance 2022-04 Impose Payment of License Fee 5% on Insurance Co and remove the additional 5% premium. Russell Forshee 2nd the motion. All were in favor. Motion carried.
- ⚡ Attorney Edison read Ordinance 2022-05 Budget Fiscal Year 2022-2023. James Tucker made a motion to accept Ordinance 2022-05 Budget Fiscal Year 2022-2023. Russell Forshee 2nd the motion. All were in favor. Motion carried.

NEW BUSINESS

- ⚡ Attorney Edison read the 1st reading of Ordinance 2022-06 Sign Permit / Approval.
- ⚡ Mayor Clark advised the need for the re-paving of Jerry Dr, Ruby Way, and Tony Ln, which would include re-milling and repaving all three streets. Russell Forshee made a motion to advertise for bid the re-milling and repaving of Jerry Dr, Ruby Way, and Tony Ln. Robert Denner 2nd the motion. All were in favor. Motion carried. Mayor Clark asked Attorney Edison to advertise for bids in the Pioneer News and contact an engineer to come out and advise the need for re-milling and paving.
- ⚡ Attorney Edison explained the need to renew the contract for police protection with Pioneer Village. The Department of Local Government requires a copy of the new contract every year. James Tucker made a motion to enter in a contract with the Pioneer Village Police Department for the Fiscal Year 2022-2023 for \$110,000.00. Russell Forshee 2nd the motion. All were in favor. Motion carried. 120,000.00
- ⚡ Mayor Clark explained the need to renew the contract for mosquito spraying with the City of Hillview. Robert Denner made a motion to enter in a contract with the City of Hillview for four mosquito sprayings during the season for \$900.00. Russell Forshee 2nd the motion. All were in favor. Motion carried.
- ⚡ James Tucker made a motion to renew the contract for snow removal and salt applications for 2022-2023 by Crocker Tree Service for \$700.00 per month from Dec 1st through March 31st with the City to purchase the salt needed. Russell Forshee 2nd the motion. All were in favor. Motion carried.

COUNCIL BUSINESS

- ⚡ Robert Denner expressed a concern with the neighbor of Russell Forshee who has a camper trailer parked in the yard, car parked in yard and tall grass.

POLICE BUSINESS

- ✦ Run Report May 210 Calls for Service to Pioneer Village Police Dept & Chief Reynolds Report:
 - 5/2 on Scenic Trail – disorderly person beating on walls. Officer was able to get them to stop.
 - 5/4 on Burkland Blvd – EPO violation. When Officer arrived, person was no longer there.
 - 5/18 on E Hebron Ln – 911 call. Was a false alarm.
 - 5/18/ on Burkland Blvd. – mother and daughter in an argument. Officer was able to calm them down.
 - 5/18 Burkland Blvd – suspicious individual. When Officer arrived, he talked to individuals, and nothing seemed out of sorts.
 - 5/19 on Scenic Trail – possible fight. When Officer arrived, there was no fight, but they were being loud.
 - 5/23 on Ruby Way – work van broken in to with check taken.
 - 5/31 at Hebron Cemetery – 51-year-old male pulled up in front of father’s headstone and shot himself in the head.
- ✦ Chief Reynolds and Detective Witherspoon explained the new Federal (unfunded) mandate for schools to have a School Resource Officer available in the schools: Maryville, Freedom and Hebron Elementary. This is a nationwide \$56 million dollar grant for the police departments to apply to receive funding for 3/4 of the officer’s salary for three years and the fourth year will be funded by the department. The grant will provide the officer’s salary plus any benefits except for equipment, uniforms, firearm, and vehicle. The officer will dedicate time to all three schools when in session and then in the summer, will work for the department. No ARPA funds can be used for this mandate of a school resource officer. Pioneer Village submitted all necessary paperwork applying for the grant for the School Resource Officer. James Tucker made a motion to draw up a Resolution for Hebron Estates and Pioneer Village to split the cost of the salary of the School Resource Officer, contingent on acceptance or rejection of the Federal Grant that was applied for. Russell Forshee 2nd the motion. All were in favor. Motion carried.


PUBLIC BUSINESS


ADJOURNMENT
