REGULAR Minutes City Council Meeting 7pm, September 5, 2023

Regular City Council Meeting of Hebron Estates, Mayor Jerry Clark called the meeting to order at 7:00pm on September 5, 2023.

All Recited the Pledge of Allegiance

- Lity Clerk McCauley read the regular meeting minutes from August 1, 2023. James Tucker made a motion to accept the regular meeting minutes as read. Russell Forshee 2<sup>nd</sup> the motion. All were in favor. Motion carried.
- → James Tucker made a motion to accept the financial report for August 31, 2023. Robert Denner 2<sup>nd</sup> the motion. All were in favor. Motion carried.

#### **OLD BUSINESS**

- 4 Attorney Edison explained the 2023 rate calculation worksheet. Robert Denner made a motion to set the Real Property AdVal Tax Rate to 8.22 cents per \$100.00. James Tucker 2<sup>nd</sup> the motion. All were in favor. Motion carried.
- 4 Attorney Edison read the 2<sup>nd</sup> reading of Ordinance 2023-03 Real Property AdVal Tax. James Tucker made a motion to adopt Ordinance 2023-03 Real Property AdVal Tax. Russell Forshee 2<sup>nd</sup> the motion. All were in favor. Motion carried.
- Russell Forshee made a motion to set the Public Service Companies AdVal Tax Rate to 10.00 cents per \$100.00. Robert Denner 2<sup>nd</sup> the motion. All were in favor. Motion carried.
- Attorney Edison read the 2<sup>nd</sup> reading of Ordinance 2023-04 Public Service Companies AdVal Tax. James Tucker made a motion to adopt Ordinance 2023-04 Public Service Companies AdVal Tax. Robert Denner 2<sup>nd</sup> the motion. All were in favor. Motion carried.
- Mayor Clark explained the School Resource Officer Agreement between the BCPS and Pioneer Village has been signed. BCPS will pay Pioneer Village up to \$60,000.00 for the SRO Officer in Hebron Middle, Freedom Elementary and Maryville Elementary Schools. Hebron Estates will annually pay 2/3 of the SRO salary which is \$45,244.97 to Pioneer Village due to two of the three schools being in Hebron Estates, Pioneer Village will pay 1/3 of the SRO salary for Maryville Elementary School. James Tucker made a motion to pay Pioneer Village for the School Resource Officer annually in July. Russell Forshee 2<sup>nd</sup> the motion. All were in favor. Motion carried.

## NEW BUSINESS

Mayor Clark discussed the ordinance violations at 3821 Scenic Trail, which the resident told the Police to get off his property after receiving several official notices and unwillingness to answer the door. The option for the City is to move forward with court proceedings. Robert Denner made a motion to move forward with court proceedings against the homeowner at 3821 Scenic Trail. James Tucker 2<sup>nd</sup> the motion. All were in favor. Motion carried.

- Kathy Merrifield said that Rapid Fuel and Snacks had done a great job with the property, store, gas station and liquor store.
